Today's program was Gary Powers, Jr. who talked about his father, <u>Francis Gary Powers</u>, whose Central Intelligence Agency (CIA) Lockheed <u>U-2 spy plane</u> was shot down while flying a reconnaissance mission in Soviet Union airspace, causing the 1960 U-2 incident.

Gary was born June 5, 1965, in Burbank, California, and he is the son of Francis Gary and Claudia "Sue" Powers.

Gary holds a Bachelor of Arts Degree in Philosophy from California State University, Los Angeles, and a Master's Degree in Public Administration / Certification in Non-profit Management from George Mason University (GMU), Fairfax, Virginia. He will graduate this year with his Master's Degree in U.S. History from Adams State University, Alamosa, CO.


Gary is the Founder and Chairman Emeritus of <u>The Cold War Museum</u>, a 501(c) (3) charity located at Vint Hill, VA 45 minutes west of Washington, DC. He founded the museum in 1996 to honor Cold War veterans, preserve Cold War history, and educate future generations about this time period. As Chairman

of the Presidential Advisory Committee for the Cold War Theme Study he works with the National Park Service and leading Cold War experts to identify historic Cold War sites for commemorating, interpreting, and preservation. Recently, he consulted for a Steven Spielberg Cold War thriller, *Bridge of Spies*, about James Donovan who brokered the 1962 spy exchange between KGB spy Rudolph Abel and CIA U-2 pilot Francis Gary Powers, Sr.


Gary is the author of *Letters from a Soviet Prison (2017)* and *Spy Pilot (2019)* which both help to dispel the misinformation surrounding the U-2 Incident. He is a Board Member of the Strategic Air Command and Aerospace Museum near Omaha, NE and an Honorary Board Member of the International Spy Museum in Washington, DC. Because of his efforts to honor Cold War veterans the Junior Chamber of Commerce selected him as one of the "Ten Outstanding Young Americans" for 2002.

Gary lectures internationally and appears regularly on C-SPAN, the History, Discovery, and A&E Channels. He is married and has one son.












CONCLUSION



BRUCE WAS BORN IN CHICAGO IN AN AREA MOST OF US WOULD NOT GO INTO IN THE WORLD WE NOW LIVE IN. IT WAS CALLED ISLAND PARK ON THE WEST SIDE. HIS DAD WAS WITH AMERICAN AIRLINES AND TOOK HIS FAMILY TO WHITTIER, CALIFORNIA, HOME OF RICHARD NIXON. HIS DAD WAS ALSO IN THE ARMY AIRCORP AND WAS ABOUT TO BE DEPLOYED WHEN THE WAR ENDED IN 1945. HIS MOM INSTALLED RADIOS IN AIRCRAFT DURING THE WAR. AFTER 5 YEARS IN WHITTIER, THEY MOVED TO PALO ALTO, BOUGHT A HOUSE DESIGNED BY EICHLER. IT WAS 1500/1600 SQFT VERY IDENTIFIABLE FLOOR PLAN WITH 3 BEDROOMS. THEY HAD A SWIM CLUB, AN EARLY VERSION OF AN ASSOCIATION. THE HOUSE IS STILL THERE. WHEN HE VISITED ABOUT 10 YEARS AGO, THE HOMES WERE SELLING FOR \$1.5 MILLION. IT IS THE HOME OF STANFORD AND A LOT OF SMALLER TECH COMPANIES. THE COST OF LIVING THERE HAS CAUSED A MAJOR CHANGE IN THE DEMOGRAPHICS HOWEVER IT IS STILL COMMUTING DISTANCE FROM SAN FRANCISCO, AFTER 2 YEARS HIS DAD WAS TRANSFERRED TO NEW YORK CITY. THEY LIVED IN WESTPORT, CONNECTICUT THE HOME OF

PAUL NEWMAN, PAUL'S WIFE STILL LIVES THERE. THEY THEN BOUGHT 2 ACRES OF LAND IN THE SMALL TOWN OF WILTON, CONNECTICUT AND BUILT A HOUSE. WILTON WAS THE OUTER EDGE OF COMMUTING TO NEW YORK CITY. A ONE HOUR 20 MINUTE TRAIN RIDE. PEOPLE ARE NOW COMMUTING 2 HOURS EACH WAY. WILTON IS WHERE HE WENT TO HIGH SCHOOL AND GRADUATED IN 1968. HE WAS ACCEPTED AT CORNELL UNIVERSITY AND HIS GOAL WAS TO BECOME AN ELECTRICAL ENGINEER HOWEVER, HE DIDN'T LIKE ENGINEERING AFTER 2 YEARS. HE LEFT CORNELL. GOT INTO THE HOSPITALITY INDUSTRY AT A HOTEL IN DOWNTOWN ROCHESTER, NEW YORK. HIS CORNELL ROOMMATE WAS THERE IN MEDICAL SCHOOL. AFTER 1-1/2 YEARS HE WAS OFFERED AN OPPORTUNITY TO DEVELOP A RESORT IN FIGI THAT WAS ABOUT 35 MILES OUTSIDE OF TOWN ON DIRT ROADS. A LOT OF THE EMPLOYEES WERE FROM AUSTRALIA. HE DID A LITTLE OF EVERYTHING, HAD A PHENOMINAL TIME AND HAD HE STAYED THERE ANY LONGER. HE PROBABLY WOULD HAVE STAYED FOREVER. THE BEACHCOMER WAS A HUGE SUCCESS AND IS NOW A GOLF COURSE AND HAS 150+ ROOMS RIGHT ON THE BEACH. HE LEFT AFTER 6 MONTHS. HE ENDED UP AT THE UNIVERSITY OF DENVER AT THE HOTEL SCHOOL A PART OF THE BUSINESS SCHOOL WHICH HE LIKED. HE GOT TO KNOW THE DEAN WELL.

AFTER UNDERGRAD, HE GOT AN MBA IN ANOTHER YEAR. HAVING WORKED IN HOTELS HE ALREADY KNEW WHAT THEY WERE TEACHING. HE GOT STRAIGHT A'S AND THE DEAN CALLED HIM IN TO OFFER HIM A PHD PROGRAM. HE TURNED HIM DOWN. HE WAS THROUGH WITH SCHOOL AND EVEN READING A BOOK FOR A YEAR. SKY CHEFS OPERATED RESTAURANTS AND FOOD SERVICE FOR AIRLINES AND AIRPORTS. HE WORKED FOR THEM FOR 2 YEARS AFTER GRADUATION AND THEN MOVED TO THE NEW YORK CITY CORPORATE OFFICE DOWNTOWN NEXT TO WHERE HIS DAD WORKED. HE THEN COMMUTED (NOT AS FAR AS HIS DAD) FROM YONKERS, 1 MILE AWAY FROM WHERE SON OF SAM LIVED IN YONKERS. HE DIDN'T REALLY LIKE IT BACK THERE AND TRANSFERRED TO PHOENIX AIRPORT AND MANAGED THE RESTAURANTS AND BARS IN THE TERMINAL. THEY WERE GOING TO SEND HIM BACK TO NEW YORK, SO HE DECIDED TO GO TO WORK FOR EAST COAST ATLAS HOTELS IN SAN DIEGO. DURING THIS TIME HE ALSO OPENED A HOTEL IN CABO SAN LUCAS. HIS BOSS ASKED HIM WHAT HE WANTED TO DO NEXT SO HE TOOK OVER THE FOOD AND BEVERAGE OPERATION FOR THE TOWN AND COUNTY CONVENTION CENTER WITH 1000 ROOMS AND MULTIPLE BALLROOMS. IT WAS A BIG OPERATION THAT HE HELPED TO GROW AND EXPAND, THIS WAS IN 1989.

HE THEN HAD AN OPPORTUNITY TO RUN THE SAN DIEGO CONVENTION CENTER OWNED BY BALLARD SMITH, WHO WAS MARRIED TO RAY CROC'S DAUGHTER. HE INTERVIEWED WITH THEM AND THEY WANTED A UNIQUE LABOR INTENSIVE RUSSIAN SERVICE, SOMETHING HE WAS FAMILIAR WITH. HE JOINED THEM 6 MONTHS TO A YEAR OFF SITE BEFOR THEY OPENED, HIRED STAFF, AND PLANNED EVERYTHING. HE HAD THREE OF THE MOST STRESSFUL THINGS GOING ON AT THE SAME TIME. OPENING A CONVENTION CENTER, GETTING MARRIED, AND BUYING A NEW HOME. HE HAD MET A WONDERFUL LADY KIM AT TOWN AND COUNTRY, THEY STARTED LIVING TOGETHER, BOUGHT A SMALLER HOME, AND DECIDED TO GET MARRIED. THEY HONEYMOONED IN KONA, HAWAII. HAD A WONDERFUL TIME. HE CAME BACK TO 100 HOUR WEEKS OPENING THE CONVENTION CENTER. IT WAS EXTREMELY SUCCESSFUL AND DOUBLED THEIR FIRST YEAR GOALS. HE WAS WITH THE COMPANY 6 YEARS. HE BECAME PART OF CORPORATE AND OTHER OPERATIONS INCLUDING DEL MAR RACETRACK, AND PALM SPRINGS POLO CLUB THAT JUST STARTED. HE STARTED THE COCHELLA CONCERT MUSIC FESTIVAL IN INDIO WITH PEARL JAM. HE ALSO DID A GAY RODEO (THEY WOULD NOT ALLOW PICTURES). EVENTUALLY THE TWO OWNERS GOT INTO A WAR AND SPLIT DIVISIONS. BRUCE LEFT AND ENDED UP WITH A

CATERING COMPANY CALLED "PICNIC PEOPLE" PROVIDING SERVICES THAT ARE STILL THERE. THEY RAN PICNICS IN THE PARKS ALL OVER SAN DIEGO FOR THOUSANDS OF PEOPLE. THE LARGEST CATERING COMPANY IN TOWN. HE BOUGHT ANOTHER COMPANY CALLED A CATERED AFFAIR. THEY DID VERY WELL. THEY DID THE HARBOR CRUISE BUSINESS, THE MARINE CORP HEAD START PROGRAM, AND MANY OTHERS. ONE STRANGE MORNING ON 9/11, ALL THE CATERING BUSINESSES CLOSED, THE HEAD START ACCOUNT FOR THE MARINES WAS THE ONLY ONE LEFT FOR A COUPLE OF DAYS UNTIL THEY CLOSED THAT ALSO. HIS OLD BOSS CALLED HIM TO DEL MAR AS THE CATERING DIRECTOR. THEY HAD FAIR GROUNDS AND 7 WEEKS OF RACING. HE RAN ALL THE CATERING SIDE OF THE FOOD SERVICE. STEVE WYNN WOULD SHOW UP ALL THE TIME. HE WAS THERE FOR TWO RACING SEASONS AND THEN RECRUITED BY LEVY RESTAURANTS IN MILWAUKEE, WISCONSIN. HE AND KIM MOVED TO MILWAUKEE WITH THE TWO KIDS KATIE AND SCOTT WHERE HE RAN AN OLD THEATER FOR A YEAR WHERE JERRY SEINFELD PLAYED ALONG WITH LOTS OF GROUPS. THEN HE HAD A CALL TO GO TO JAKSONVILLE, FLORIDA. HE HAD TO GO IMMEDIATELY! HE BOUGHT A NICE HOUSE OUTSIDE JACKSONVILLE. THE FAMILY MOVED DOWN. THE GUY THAT BROUGHT HIM DOWN LEFT SHORTLY

THEREAFTER, NOT A GOOD SIGN! HE THEN MOVED TO CRANBERRY, PENNSYLVANIA OUTSIDE OF PITTSBURG, NEW HOME OF A CAMPUS FOR **NUCLEAR PLANTS. THREE MOVES FOR KIDS IN HIGH SCHOOL NOT GOOD!** CONVENTION CENTER DID WELL HOWEVER, THE WEATHER WAS AWFUL. IN ADDITION, CORPORATE AND BRUCE DIDN'T AGREE ON HIS MOVING EXPENSES SO HE WENT BACK TO SAN DIEGO. HE WORKED AT SHERATON HARBOR ISLAND FROM 2008-2009. THE RECESSION HIT AND HE WAS AGAIN LAID OFF. HE GOT A JOB IN SAN JOSE WITH CLUB CORP WHICH OWNS CANYON GATE HERE IN LAS **VEGAS. HE WAS THERE FOR 10 YEARS, EXPANDED MEMBERSHIP WHICH WAS** CALLED CAPITAL CLUB. THEY WERE BOUGHT OUT BY A PRIVATE EQUITY FIRM. THE COMPANY CHANGED A LOT IN 2019-2020. HE RESIGNED MARCH 17, 2020 THE DAY THE WORLD SHUT DOWN TOTALLY UNRELATED TO COVID. HE ARRIVED IN LAS VEGAS APRIL 1, 2020. THEY HAD PREVIOUSLY BOUGHT A HOME HERE IN LAS VEGAS AS A RETIREMENT HOME AND SETTLED IN THERE. KIM HAD FRIENDS HERE, ACTUALLY SHE HAD GROWN UP HERE. HER DAD AND STEPMOM WERE MUSICIANS. HER DAD, GARY SCOTT, PLAYED 8 WIND INSTRUMENTS AND PLAYED IN SINATRA'S ORCHESTRA. KIM HAD WORKED AT HOME DEPOT EVERY WHERE THEY LIVED SO SHE WENT TO WORK AT HOME DEPOT HERE.

THEIR DAUGHTER, KATIE, HAD JOINED THE NAVY, A SELECT INTELLIGENCE

Frank was born in San Marino, CA, where he lived until his graduation from USC. He received a degree in business with an emphasis on finance and accounting. Then, he went to work for his grandfather in West Texas on the ranch. They grew crops on 76,000 acres and had 600 employees. This is when Frank got involved in crop cost accounting.

After that, he worked with Arthur Andersen in San Francisco. When he took the job, he thought he would be moving to Los Angeles because of the things the company was saying. However, it didn't work out that way. Frank's wife was from San Francisco. She was delighted to be going home.

Janet and Frank met at USC, the "University of Second Choice" for Janet. She wanted to go to Stanford. Her grandfather, Donald "DJ" Russell, was a trustee there. He was one of the founders of Stanford Research Institute, and a chairman of Southern Pacific Railroad.

He was born in 1900 and spent his whole career at Southern Pacific. He was too tall to fly airplanes for the United States, so he went to Canada and flew planes in World War I.

Needless to say, Frank and Janet enjoyed being part of the grandparents' lives. Louise was Janet's grandma. She lived to be 99 ½. She used to be Frank's Clipping Service. She would clip out articles she thought he would be interested in for years. Frank and Janet have fond memories of her grandparents.

Frank worked for Arthur Andersen for 5 business seasons and had started some real estate development. He was looking for office space, nothing fancy, when he was offered a position he could not turn down. DN&E Walter & Co., founded in San Francisco in 1853, had been in manufacturing and were left with the real estate and securities. Frank became their treasurer. He had been one of their auditors for 4 business seasons, or about 4 ½ years.

They paid his overhead and allowed him to have total control over half of his time. He was there for 7 years. In his second year, he and the president contracted Legionnaires' disease. He died, obviously Frank survived. He then became the executive vice president and basically ran the company for the next 5 years. Because this was taking a lot of his time, he needed to spend time on the real estate development side, so they founded a new company.

They became the partner of the new company, Walter-Abbott Corporation. They hold real estate assets. Their primary function is as landlord. Frank is now the sole shareholder.

Back in 1987, Frank and his brother started a Development Services Company. They developed industrial factory warehouse distribution centers they own and lease. These assets are in Northern and Southern California, Las Vegas, and Dallas. They have 70 different types of tenants. One is the UPS distribution Center in Dallas. One year when developing the project, Frank was able to arrange his schedule so he could attend 43 Rangers games. It was when they had built a brand new stadium in Arlington, Texas.

Along the way, he and Janet had 2 boys and 6 girls. His son Frank III works with the company. His daughter Leslie does the interiors, another daughter Christina works in accounting. They have 7 ½ grandkids, 8 in February. Frank still travels a couple of times a week. He will be starting a new project they are looking at in Austin, TX. They are looking also in Loudin County, Virginia, close to D.C. where a lot of data centers are located. There is a need for "last mile of eCommerce" data facilities.

Their multi-tenant facilities provide dock high loading for spaces as small as 4,000 to 5,000 square feet. About 40% of their spaces have dock high loading. They also have Early Suppression, Fast Response (ESFR) that requires water sources for two loops that allows them to stack above 12 feet and 2 feet below the sprinkler system. This allows them to charge premium rents for space.

Frank is currently working on a project near Post Road and Decatur. They will likely have a final map in December. They are at the end of the flood channel where the county streets run off in their property now. They have designed a

drainage system that conveys all of the water into the Tropicana basin, thereby enabling them to develop the property. About 87% of the water comes into their property from offsite. They are doing some very innovative things in their development, including providing a new approach to WiFi service.




