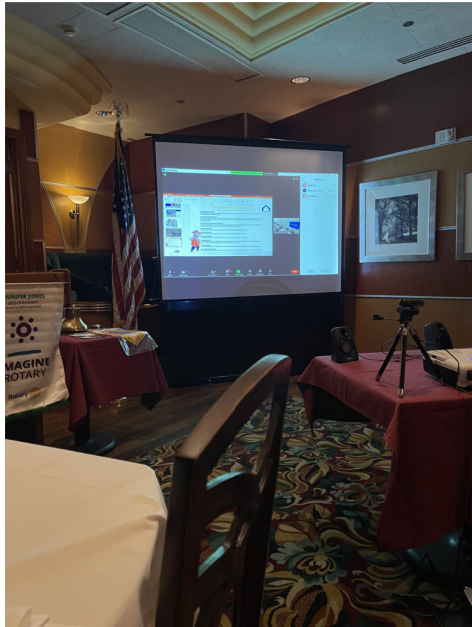

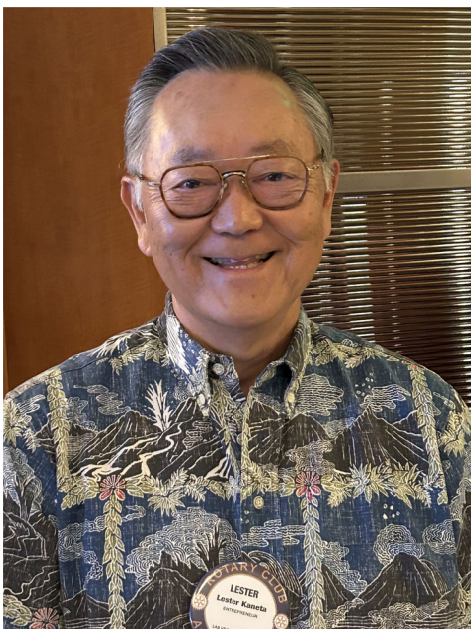
PROGRAM

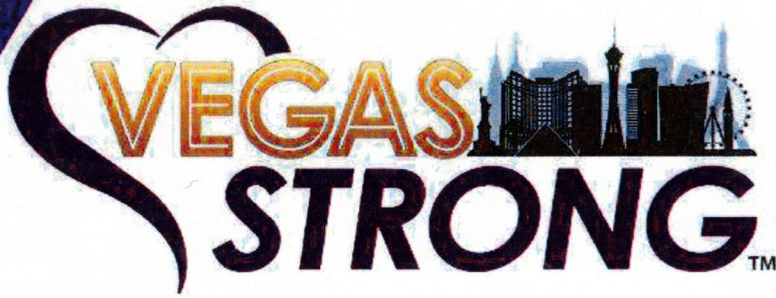

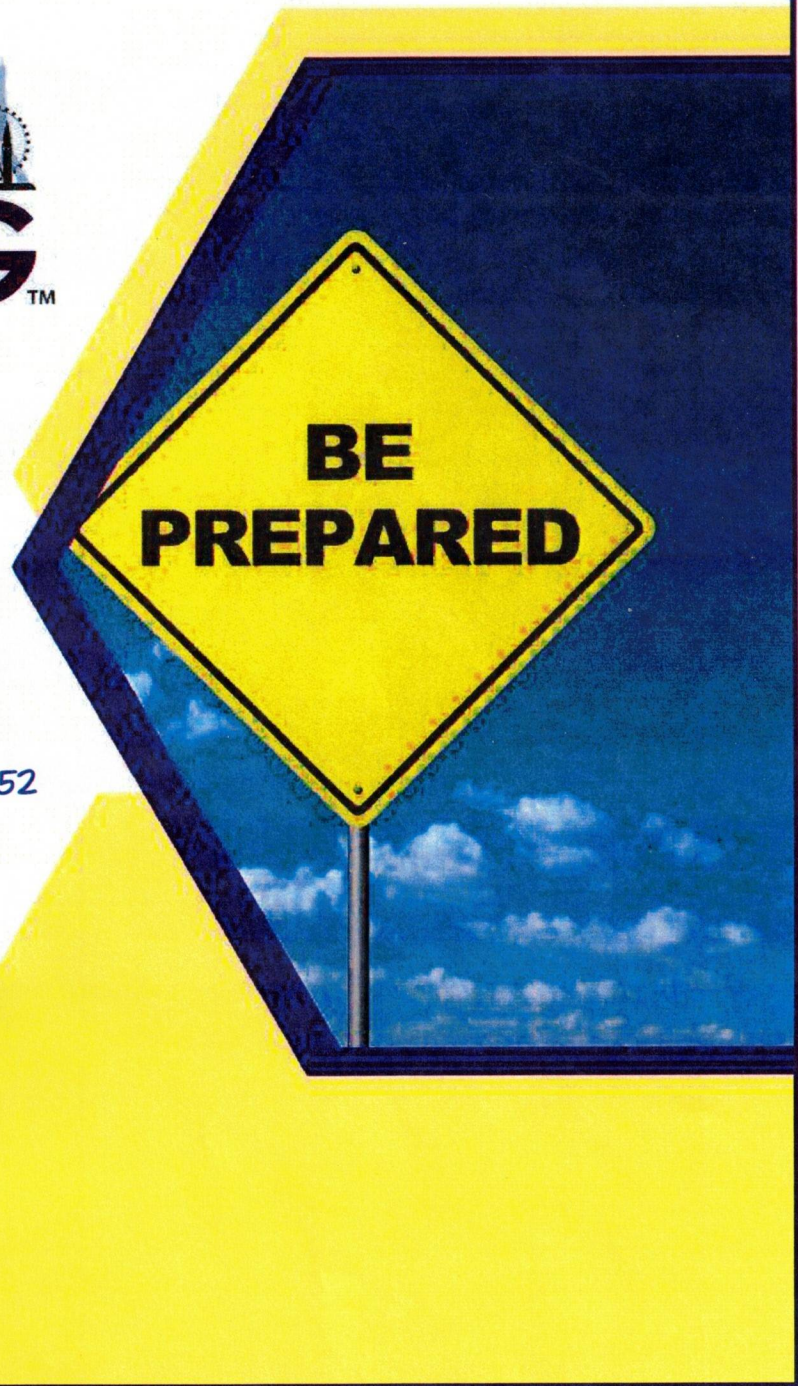

BOXABL INTRODUCTION

Boxabl was started in 2017 by Paolo Tiramani, Galiano Tiramani, and Kyle Denman. After several years of prototyping and testing materials, the Boxabl Casita was introduced in early 2020 and started production in 2021.



The Boxabl mission is To revolutionize the standard of housing construction and affordability with an innovative, technology-based solution to mass-produce homes through advanced manufacturing.

Frequently Asked Questions



How long will the product last?

We expect these units to last longer than traditional buildings. We have done extensive testing on how our units might stand up to wind, fire, water and other elements that usually degrade a building.

Can you tell me more about the roof?

The stock Casita has a flat roof with TPO membrane that is watertight, insulated and snow load rated. Some areas will require a pitched roof, in that case, you will add a roof solution on-site with your roofing contractor. In the future, we hope to provide plans for this and potentially a roofing solution that we will sell separately.

How insulated and energy efficient is a Boxabl unit?

The house is very well insulated. The walls have a nominal R value of R-22. The building envelope is very tight, reducing air leakage and they don't have traditional lumber studs that contribute to thermal bridging. Our initial tests show a HERS score of 40.

Is this earthquake tested?

The Casita is expected to be rated for all earthquake zones. Soon, we will publish the exact test data on our website.

Are they wind-resistant?

The Casita walls can handle hurricane-speed winds. Soon we will be publishing exact test data on our website.

Are they flood-resistant?

Boxabl doesn't use lumber or sheetrock. The building materials are less likely to be damaged by water or grow mold.

Are they fire-resistant?

Nothing is fireproof. But Boxabl was engineered with fire resistance in mind. The interior and exterior of the structure are clad with non-combustible materials. We think this means flying embers that spread forest fires won't ignite your Boxabl.

Can they handle snow?

The Casita's snow load is rated for most of North America and can be retrofitted for the rest. Soon we will publish exact test data on our website.

What codes do they comply with?

Boxabl buildings will exceed the requirements of most building codes. They will come with state modular certifications and park model RV certifications.

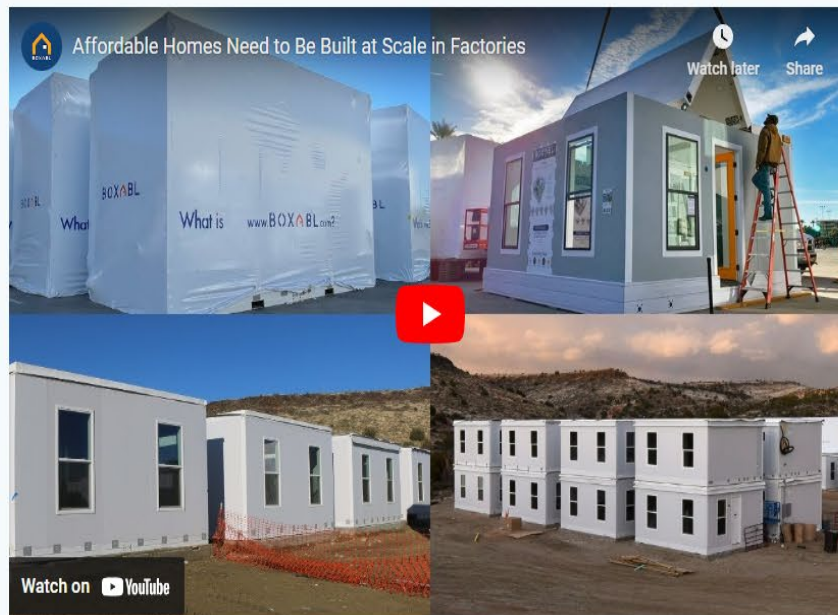

After the war in 1945, the Club started to function again, growing steadily in number each year making significant contributions to the welfare of the community and in promoting international understanding. By 1952, the Rotary Club of Johore Bahru became a reality. Then came the Rotary Club of Singapore West in 1960 and the Rotary Club of Singapore East in 1965.

Originally, Rotary Clubs in Singapore were part of the Rotary district which covered seven countries: Thailand, Malaysia, Singapore, Vietnam, Cambodia, Laos and Brunei. After the Vietnam War, the District was narrowed down to Thailand, Malaysia, Brunei and Singapore. Subsequently, Thailand became a new District, and later, our current District 3310 was formed with Singapore, Johore, Malacca, Sabah, Sarawak, Labuan, and Brunei.

The Rotary Club of Singapore East resides within the Rotary District of 3310. The District is rich in cultural diversity with people from many racial groups (including Malays, Chinese, Indians and indigenous groups and tribes) living harmoniously together.

Inner Wheel Clubs

Inner Wheel is an international organization founded in 1924 to unite wives and daughters of Rotarians. Inner Wheel Clubs exist in over 103 countries. Like Rotary, Inner Wheel is divided into local clubs and districts. Female spouses of Rotary members are traditionally called "Partners" or "Spouse".

Rotaract Clubs

Rotaract is an organisation for university age and young professionals who take action through community and international service, learn leadership skills, and participate in professional development. Rotaract clubs are either community or university based. "Rotaract" stands for "Rotary in Action", and its motto is "Self Development – Fellowship through Service".

In 2019, Rotaract went from being a program of Rotary International to being a membership type of Rotary International, elevating its status to resemble that of Rotary clubs. As of 1 July 2020, Rotaract clubs can exist on their own, or may be sponsored by Rotary and/or Rotaract clubs. This makes them true "partners in service" and key members of the family of Rotary. A Rotaract club may, but is not required to, establish upper age limits, provided that the club (in accordance with its bylaws) obtain the concurrence of its members and the sponsor club(s) (if sponsored).

Interact

Interact is Rotary International's service club for young people ages 12 to 18. Interact clubs are sponsored by Rotary clubs (and may be co-sponsored by Rotaract clubs), which provide support and guidance, but they are self-governing and self-supporting.

The Rotary Foundation (TRF)

The Rotary Foundation of Rotary International is Rotary's charity and Rotarian's Charity of choice. It can be described as the engine that propels and funds the various humanitarian projects of Rotary International.

The Rotary Foundation is a not-for-profit corporation, supported solely by voluntary contributions from Rotarians and friends of the Foundation who share its vision of a better world. It is registered in the USA as an International Charitable Trust.

The mission of The Rotary Foundation is to enable Rotarians to advance world understanding, goodwill and peace through the improvement of health, the support of education, and the alleviation of poverty. Its motto is simply "Doing Good in the World".

The Rotary Foundation is governed by a Board of Trustees, separate from the Rotary International Board of Directors. Whereas the RI Board members have a tenure of two years, Trustees serve a term of four years.

The Rotary Foundation, established as an endowment fund in 1917, enjoyed modest growth until 1947 when Rotarians made a significant number of contributions in memory of Paul Harris who died in January 1947. That same year The Foundation launched its first programme, Graduate Fellowships (today called Ambassadorial Scholarships) sending 18 students abroad to 7 countries. Today, more than 1200 Rotary Scholar are studying abroad every year.

Rotary club and Rotarians raise and contribute funds to The Rotary Foundation annually enabling humanitarian work to be done around the globe. Clubs are regularly applying for use of these funds for local and international projects providing access to funding not otherwise achievable given their size.

Today the fund is almost US\$1 billion. Its unique funding model provides for a perpetual capital resource which annually funds thousands of club projects all over the world through Rotary District and Global grants.

The FIVE Avenues of Rotary International Service and its Mission Objectives

Rotary's ideal of service is based on the Five Avenues of Service – Club, Vocational, Community, International and New Generations – that comprise Rotary International's philosophical cornerstone. Rotary clubs carry out efforts along each avenue in support of the Object of Rotary.

Club service works to strengthen fellowship of members through training and hospitality. Clubs have serious topics to work toward, so having various social events that bring members and their guests informally and for fun, contributes to genuine fellowship.

Vocational Service encourages members to serve other people through their vocations, education, skillsets, which encourages high ethical standards. October is Vocation Service Month when the many club service projects are celebrated.

Community Service is exactly what the name implies — projects and activities each club undertakes to improve community life.

International Service volunteers work to expand the Rotarians' humanitarian work around the world. This important service promotes understanding and peace, sponsors projects in other countries and works with international partners to support projects in their communities.

New Generations Service works to **engage youths and young adults in leadership roles.** Rotary Youth Leadership Awards (RYLA) is a training program for young people, ages 14 to 30. The award emphasizes leadership and citizenship. Rotaract is an International Youth Program is for ages 18 to 30 while Interact focuses on international service for youths 12 to 18

The above avenue of services Director are selected to serve on an annual basis including the President of the Club; The Vice-President; The President Elect (The in-coming President for the next Rotary Year) and The Treasurer.

In our club, we have another avenue of service which is Club Image whose responsibility is to create awareness for our club and the projects that we undertake. 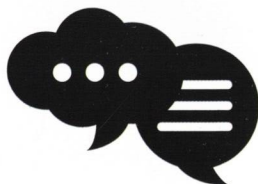
Additional information
