RECOGNITIONS

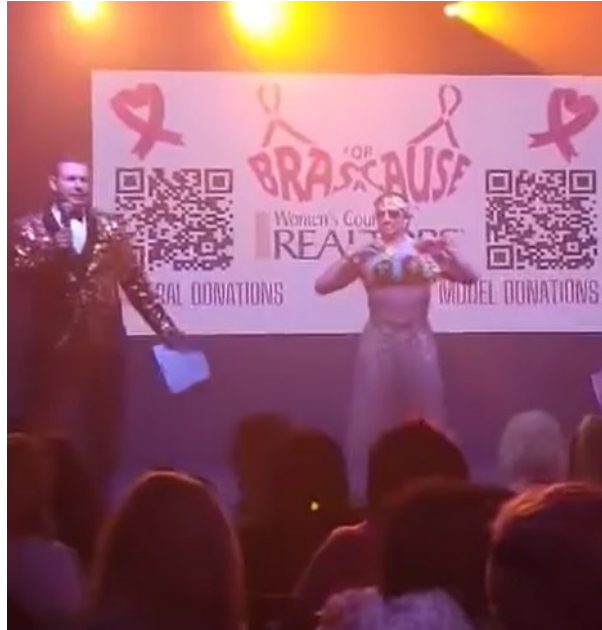

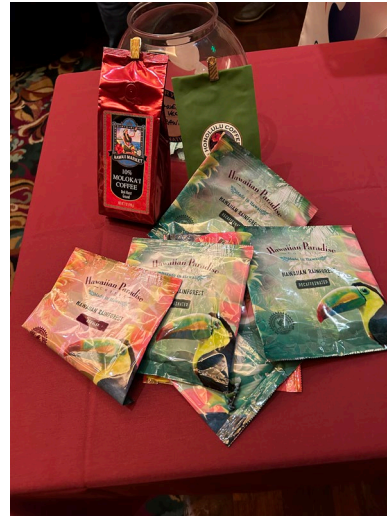

While she does teach here in Southern Nevada, dive instruction is not her day job. She works with the State of Nevada managing environmental compliance for potentially impactful transportation projects.

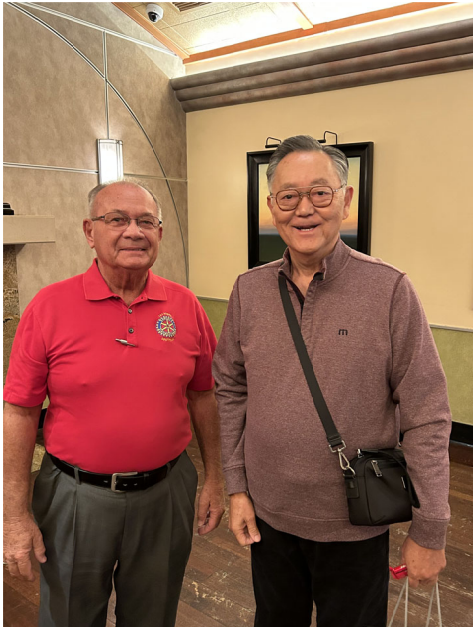
