Pres. Joe had a series of trivia questions.

- 1. When and what year was Rotary started? **Jack Woodcock** correctly stated 1905 and added that it was the same year that Las Vegas was founded. And, no, **Jack** wasn't around to see those events happen! \$50 credit.
- 2. What is the significance of the Rotary wheel? Chris Publow correctly stated that the first meetings rotated between members' business locations. Pres. Joe added that the wheel has been the symbol of Rotary since the earliest days. The first design was made by Chicago Rotarian Montague Bear, an engraver who drew a simple wagon wheel, with a few lines to show dust and motion. The wheel was said to illustrate "Civilization and Movement." \$50 credit.
- 3. What year were women admitted to Rotary. Francesca Gilbert correctly reported 1987.
- 4. What well known philanthropist and business man was an early member of RI? W. Clement Stone
- 5. What is the highest level of recognition in Rotary? It is the Rotary Service Above Self Award awarded to those Rotarians who demonstrate their commitment to helping others by volunteering their time and talents. **Greg Mottau** said he knows a Rotarian in Oregon who has received the award for spending 7 years in Africa building hospitals.
- 6. What is the name of the monthly Rotary magazine? **Fred Fukumoto** correctly said it was the Rotarian, for which he received a \$50 credit.
- 7. What is the Rotary motto? Lori Clarke correctly said "Service Above Self"

Pres. Joe called for volunteers to do a \$50 "Happy Bucks" shoutout for their business:

- 1. Francesca Gilbert said that she has unretired and is now back selling residential real estate after a year of relaxing and failing to enjoy golf. She has been in real estate for 35 years (and 4 months) with the same company, Berkshire Hathaway. ### JOKE OF THE DAY


