### SPEAKER

**Terri Jones**, who is the Chair of the Hospitality Management Department at the College of Southern Nevada was our speaker today.

She came to UNLV in 1982 to work on a second baccalaureate degree but was persuaded to do a master's degree. After a short stint at UNLV, she began working at CSN where she has been for the past 30 years.
