Dave Swallow, from the Regional Transportation Commission of Southern Nevada (RTC) was our speaker today. He came to Las Vegas 38 years ago when his father was stationed at Nellis Air Force Base. He is a licensed professional engineer in the state of Nevada and earned a bachelor's degree in science and a master's degree in civil engineering from the University of Nevada, Las Vegas.

He is the Deputy CEO for the RTC and, in this role, he oversees the agency's planning, engineering, and funding programs for transportation infrastructure, development of new transit facilities and systems, implementation and support of new technologies and coordination between roadway and freeway operations.





A civil engineer with more than 26 years of transportation-related experience, he has been with the RTC since January 2001. His team comprises several departments, including the Metropolitan Planning Organization, Capital Project Development, Streets & Highways, Information Technology, and Traffic Management.

Dave and his team are focused on developing a long-term vision and related plans for improving mobility in Southern Nevada; administering a capital improvement program of roadway and multi-use trail projects; developing high-capacity transit lines on key corridors; managing the public bike share system; and overseeing traffic operations and incident response for the region's

network of roadways and freeways.

We received an excellent and informative presentation that, as usual, sparked a lot of questions from our members.
