Since its inception, the 98.5 KLUC Chet Buchanan Show Toy Drive has grown to become recognized as "The World's Largest Single Location Toy Drive."

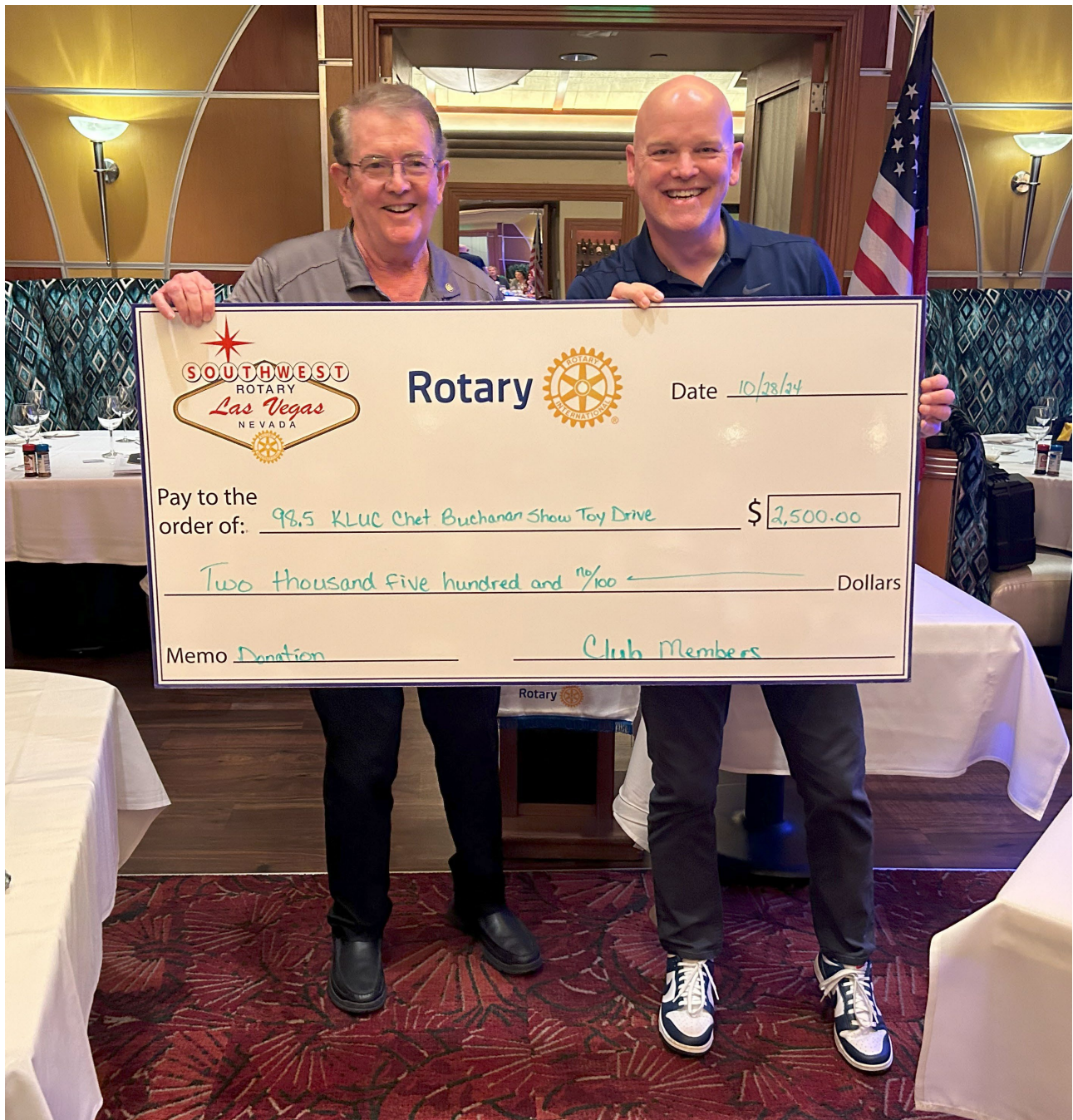

compassionate...competitor. Always looking to improve, grow, and discover new ways to win, along with new challenges to conquer!"



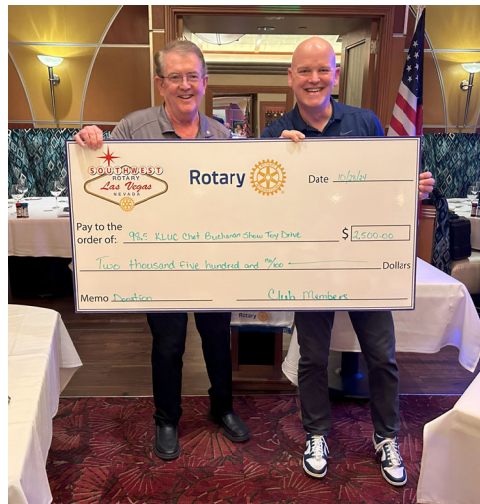
