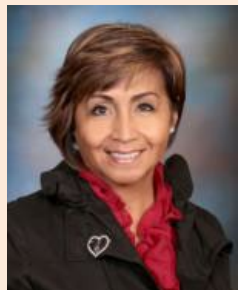

5. Help maintain a harassment-free environment in Rotary meetings, events, and activities, report any suspected harassment, and help ensure non-retaliation to those individuals that report harassment.

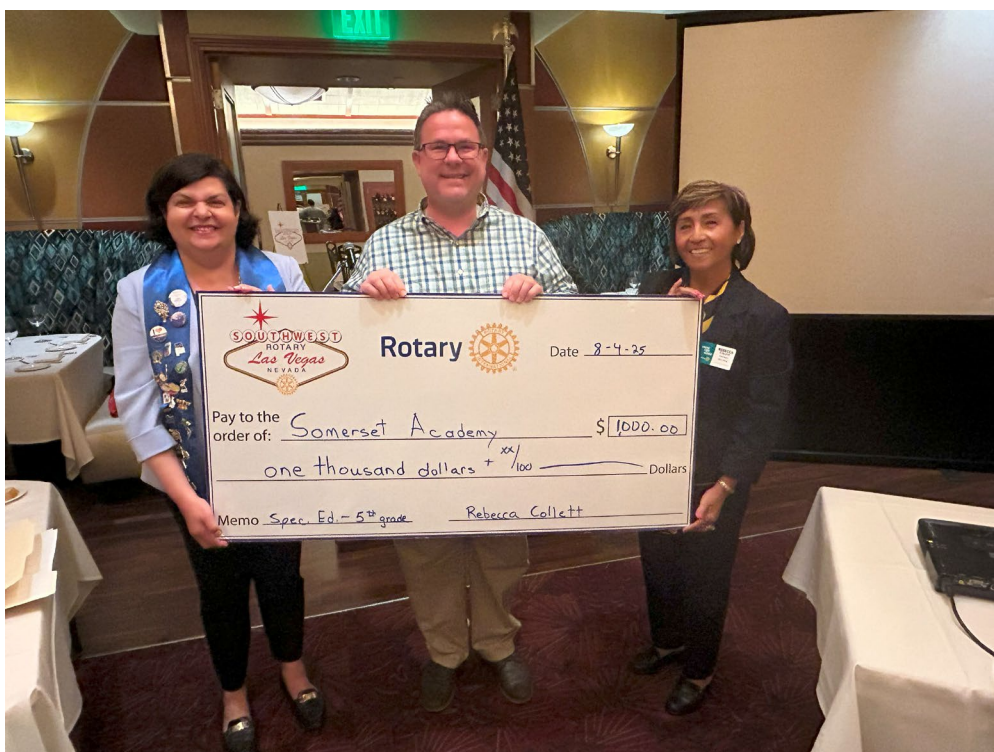

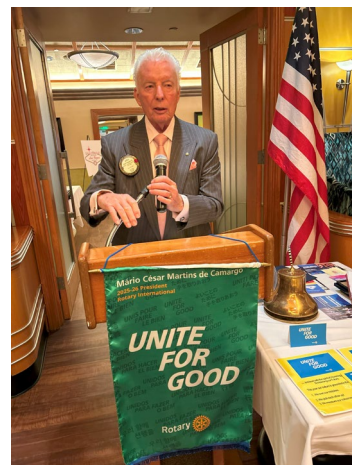

INDUCTION CEREMONY – MICHAEL KROKOWER



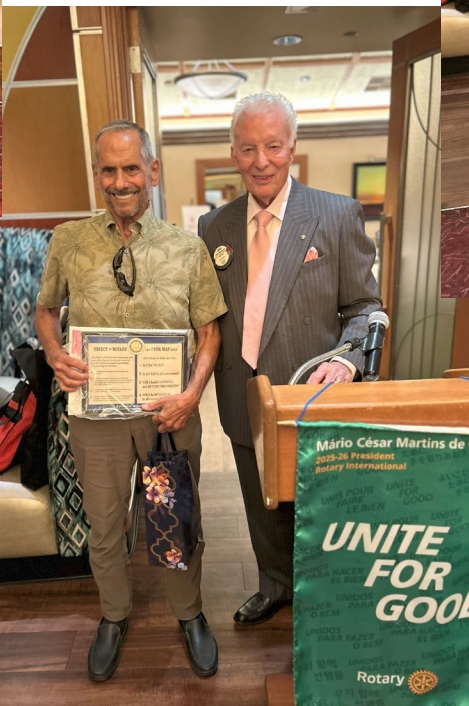

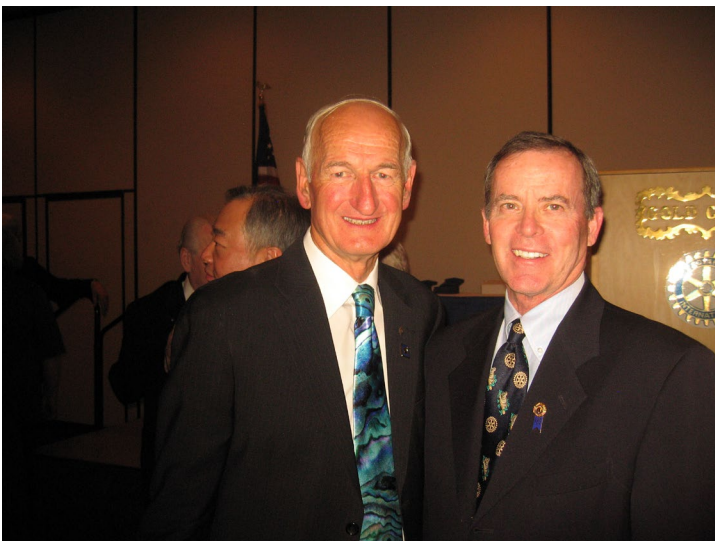

PROGRAM

[Gilda Moshir](#) - District 5300 Governor was our speaker today. Please check out the attached presentation slides which show the exciting things happening in the District and how we can all help in achieving her goals for the year. She has hit the ground running and it looks like it will be a very interesting year.

She is a Life Insurance Broker and prior to life insurance, ran a nursery school with a 70-year history in Pasadena. She immigrated to the US after the 1979 Revolution in Iran, when the monarchy was overthrown and has a degree in Social Ecology and Political Science from UC Irvine, and an Associate degree from Pasadena City College in Education.

Shortly after graduation from UC Irvine, **DG Gilda** met her husband, **Mehrdad**, also Persian, who is an astrophysicist who worked for Caltech/JPL and now Aerospace Corporation. They raised their 2 boys, in San Marino and now live in Pasadena near Huntington Gardens and Caltech. On September 3rd, they celebrate 32 years of marriage.



DG Gilda was inducted into San Marino Rotary in 2012 and served the club as its Membership Chair, Community Grants Chair, RYLA Chair, Mini Grants Chair, Barth Scholarships Chair and as a member of the club board and the Charities Board ultimately becoming club president in 2016-2017.

She has been active in the community, from being involved in the PTA at Valentine Elementary School in San Marino to becoming Committee Chair of her boys' Boy Scout Troop 359 in San Marino. She and **Mehrdad** are proud parents of 2 Eagle Scouts. She won the "Honorary Service Award" in 2008 from the PTA in San Marino and chaired a major fundraiser at Valentine not once but twice. As her kids grew

older, she got involved in Rotary and other organizations, she was involved in the local Chamber of Commerce for over 10 years and served as President for South Pasadena Connections, a chapter of TEAM Referral Network. In 2022, **DG Gilda** founded Homayoun Language & Cultural Center (named after her father) to serve Persian families in the San Gabriel Valley teaching children the Persian language & culture of Iran.

BOB AS A CONSULTANT, WAS INVOLVED IN THE IRVINE RANCH REAL ESTATE TRANSACTION OFTEN REFERRED TO AS ONE OF THE LARGEST TRANSACTIONS EVER ENTERED INTO. HE WAS A REAL ESTATE CONSULTANT FOR MOST OF HIS LIFE. HE IS NOW RETIRED. HE AND HIS WIFE RUN A DOG RESCUE OPERATION IN SEATTLE. BOB DRIVES DOGS AROUND SEATTLE ALL DAY LONG.

BOB'S PARENTS MOVED TO MID TOWN LA WHEN HE WAS A YEAR OLD. MICHAEL GRADUATED FROM HIGH SCHOOL. HE WAS A MEMBER OF THE HIGH SCHOOL CLUB AND DID CRAZY THINGS. THERE IS A GREAT STORY

ABOUT HIM AND A FEW FRIENDS. THEY TOOK A TRIP TO MEXICO AND GOT STRANDED ABOUT 500 MILES BELOW THE BORDER IN UNCHARTED TERRITORY. AFTER GRADUATION HE DIDN'T WANT TO GO TO COLLEGE. HE TOOK A TRIP AROUND THE UNITED STATES AND TORONTO. HIS STEPDAD'S SISTER TOOK HIM IN FOR ABOUT A MONTH. WHILE THERE, HE ATTENDED A SHAKESPEAREAN PLAY CALLED HAMLET WITH RICHARD BURTON. ELIZABETH TAYLOR WAS ALSO THERE. HE ALSO WENT TO A BILL HALEY AND THE COMETS CONCERT. ONE OF THE REASONS HE WENT BACK TO TORONTO WAS HE KNEW A YOUNG LADY IN LA THAT MOVED BACK THERE. FROM THERE HE WENT TO DETROIT IN OAK PARK AND STAYED WITH HIS AUNT AND UNCLE FOR 6 MONTHS. HE TURNED 21 YEARS OLD IN DETROIT. HE THEN WENT TO NEW YORK FOR ABOUT A MONTH, TOOK A TRAIN TO NEW ORLEANS. HE LEFT THERE AND WENT TO TEXAS FOR A WEEK OR SO, THEN NEW MEXICO AND THUMBED A RIDE BACK TO LA. HE HAD SOME GREAT EXPERIENCES. IT WAS MUCH SAFER BACK THEN TO HITCH A RIDE SOMEWHERE. AFTER THIS TRAVELING, HE WORKED AT FELDMAN LIGHTING FOR A COUPLE YEARS. AFTER THAT, HE WENT ON TO WORK FOR A COMPANY CALLED LIGHTOILER OUT OF NEW YORK FOR 4 OR 5 YEARS. HE MOVED BACK TO WORK AT FELDMAN

LIGHTING. THEN, THE ECONOMY WENT SOUTH. HE WAS OUT OF WORK FOR ABOUT A MONTH, WENT INTO A PARTNERSHIP WITH A FAMILY FRIEND OPERATING A PIONEER CHICKEN FRANCHISE IN MARINA DEL REY. THAT LASTED FOR ABOUT 8 MONTHS, 3 DAYS, AND 7 HOURS, BUT WHOSE COUNTING. HE SAYS IT WAS THE MOST STRESSFUL JOB IN HIS LIFE. MICHAEL GOT MARRIED TO MICHELE WHEN HE WAS 23. THEY ADOPTED BRAD AND SHORTLY AFTER SHE GOT PREGNANT WITH AARON WHICH IS OFTEN THE CASE. THEY WERE TOGETHER FOR 10 YEARS, GOT DIVORCED, AND HE RAISED THE 2 BOYS ON HIS OWN. TWO OR THREE YEARS LATER, HE MARRIED KELLEY. AFTER A FEW YEARS, THEY ADOPTED TWIN BOYS ROI AND JESSE. HE AND KELLEY WERE MARRIED FOR 25 YEARS, THEY HAD A GREAT LIFE IN MONTEREY CALIFORNIA.

AFTER PIONEER CHICKEN, HE ANSWERED AN AD IN THE LA TIMES TO SELL HARD SURFACE MANNINGTON FLOORING. HE GOT AN ACCOUNT LIST AND STARTED SELLING FLOORING. HE WORKED FOR DIAMOND W SUPPLY A LARGE FLOORING DISTRIBUTOR FOR 5 YEARS. HE GOT AN OFFER TO SELL ARMSTRONG FLOORING UNTIL THE MARKET FELL APART IN 1998. THAT WAS WHEN HE MOVED TO MONTEREY CALIFORNIA WHERE HIS FRIEND HAD A CARPET STORE. THEY WENT INTO BUSINESS

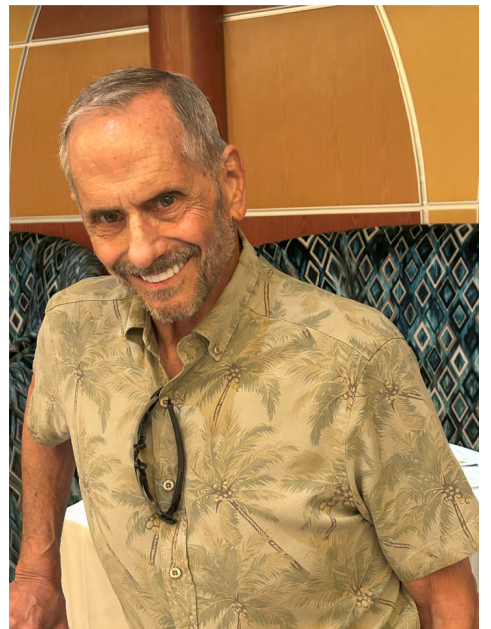
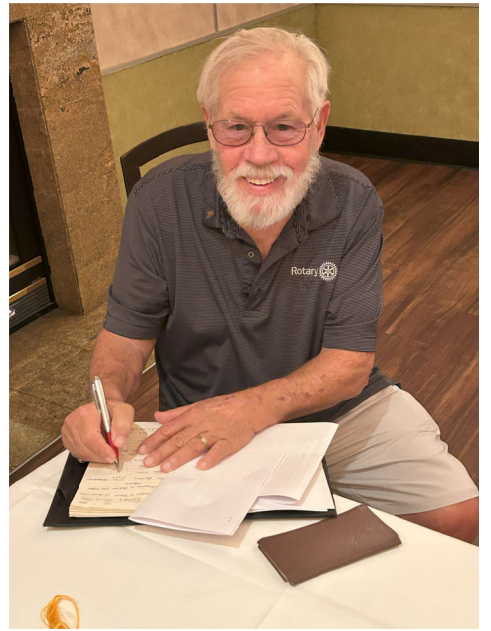
TOGETHER. THAT IS WHEN HE JOINED ROTARY. ABOUT A YEAR LATER, HE OPENED HIS OWN BUSINESS MYKELS INTERIORS. KELLEY WAS AN INTERIOR DESIGNER. THEY DID CARPET, FLOORING, DRAPERY, AND UPHOLSTERY. THEY HAD THIS BUSINESS FOR 25 YEARS. HE STATES THAT ROTARY REALLY CONTRIBUTED TO HIS SUCCESS. ONE OF THE STANDOUT MEMORIES WAS WHEN HE AND KELLEY ADOPTED THE TWINS. THE CLUB GAVE THEM A SHOWER. HE DID NOT HAVE TO BUY DIAPERS FOR AT LEAST A YEAR.

IN 2015, HE AND KELLEY GOT DIVORCED. SHE GOT MARRIED TO HER HIGH SCHOOL SWEETHEART AND THE TWINS WENT WITH HER TO MISSOURI. THEY HAVE DONE WELL. ROI IS A SOCIAL WORKER IN MISSOURI AND JESSE IN AN ENVIRONMENTAL BIOLOGIST DOING RESEARCH. HE IS VERY PROUD OF HIS BOYS.
