Becky Dutro was our speaker today. She has been with Nevada Taxpayers Association since early 2024 and was named President in June of this year. She is responsible for the day-to-day operations of the Association and membership coordination. She was the lead lobbyist for the Association and its members during this Legislative session.

Prior to that, **Becky** was an employee of Clark County for over 30 years, including 20 years in the Clark County Treasurer's office. She served as Assistant Treasurer for 10 years in that office and is well versed in Nevada's property tax structure. During her tenure at Clark County, she worked closely with the Finance, Assessor and Recorder's offices; Nevada Department of Taxation; as well as the Nevada Taxpayers Association. This experience has given her a well-rounded knowledge of tax issues in the State.

Becky is originally from Minnesota but has been a Nevada resident for almost 40 years. She earned her Bachelor of Science in Accounting and Masters in Public Administration from the University of Nevada, Las Vegas.

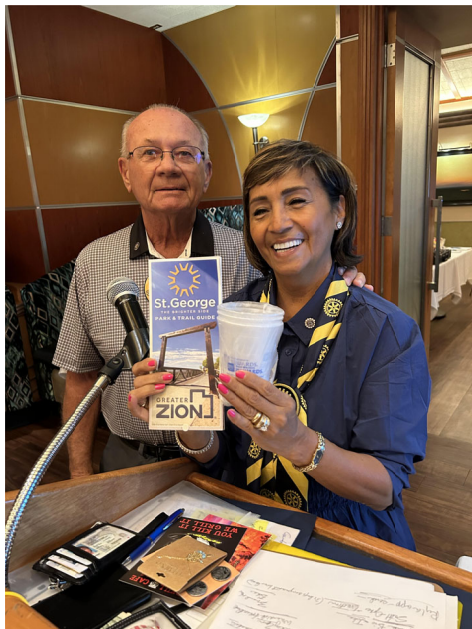


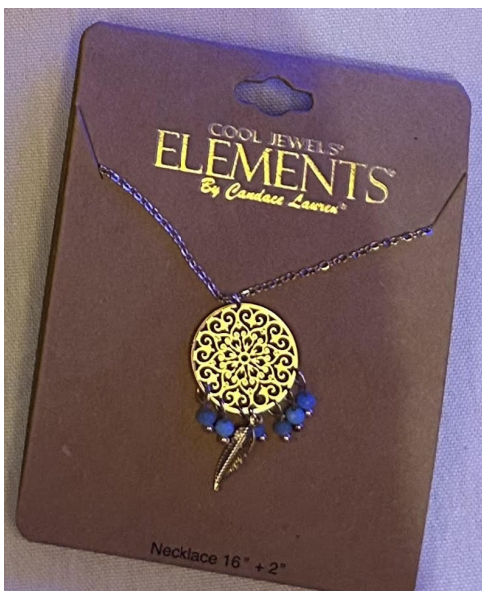
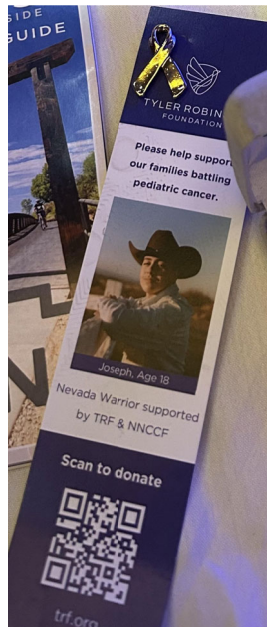

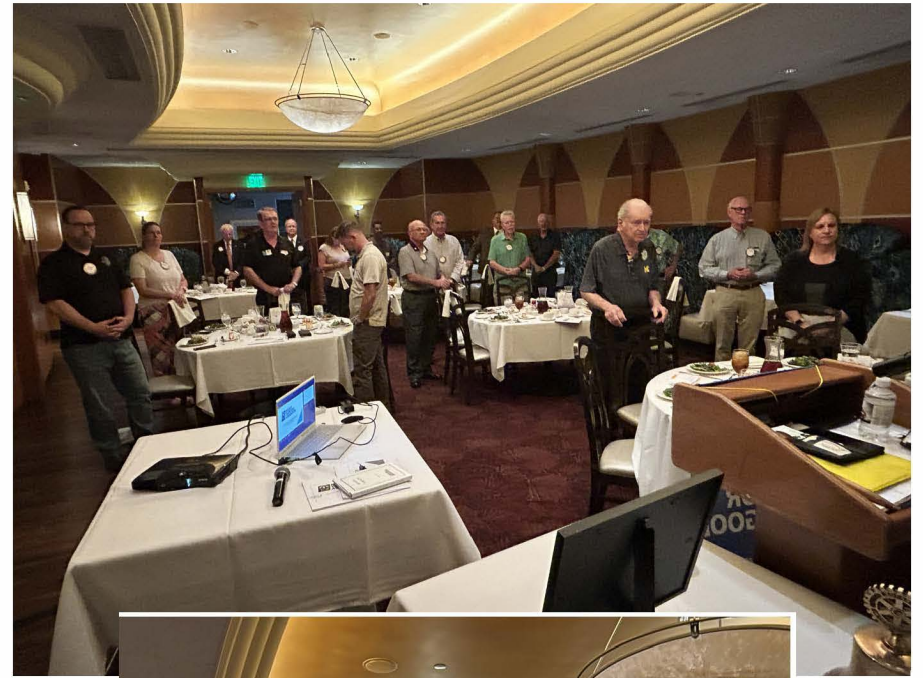












Rotary Club of Las Vegas Southwest

For over twenty years, the Rotary Club of Las Vegas Southwest has worked with various elementary schools to put shoes on children. The project, called “Happy Feet”, provides a great hands-on opportunity to serve our community and made the lives of young people just that much happier.

Each month during the school year, and working with the school counselor, one grade is selected and the counselor measures each child’s feet and sends us the sizes. We work with Skechers to buy the shoes and then on the selected day, Rotarians and other volunteers, show up and literally put the shoes on the children, making sure they are the right fit, etc. Each child also receives two pairs of new socks.

Interactions with the children are heartwarming and they are always appreciative. It is not just the children who benefit, but the Rotarians and other volunteers all report that this project is one of the most fulfilling.

For the past five years or so, we have been working exclusively with a Title 1 elementary school in an underprivileged area. The school, William E. Ferron Elementary School, was named after an early Las Vegas pioneer who arrived in Las Vegas in 1915. He was a pharmacist and a prominent Las Vegan who served as mayor and who was also a charter member of the Las Vegas Rotary Club.

2025 LEGISLATIVE RECAP

- Session began with a budget as introduced that was unbalanced and had a structural deficit and ended with the record number of vetoes.
- Decline of C-tax, gaming, and capped property tax means looking for other revenue sources
- Larger presence this session than past few years; testified on 12 bills – mainly to educate on the guiding principles of good tax policy
- NTA was monitoring almost 100 bills related to taxation and exemptions and major budget implications
- Key legislation that passed:
 - AB 594 – changes filing due date of Sales & Use Tax from last day of the month to the 20th of each month – passed
 - AB 558 – Transfer of \$350 million from Rainy Day Fund
 - SB 451 – Extension of Property Tax for LVMPD

2025 LEGISLATIVE RECAP (CONT.)

- Bills that did not pass – watch list for interim & 2027 session
 - AJR 1 – Property Tax – reset of depreciation and tax cap abatement upon sale of property
 - AB 453 & SB 431 – “Kitchen sink” of tax bills – Sales & Use Tax on digital good and digital advertising; L.E.T. tax on resale of event tickets and removal of exemption on Nevada profession sports team events; lowering of threshold for Commerce tax
 - AB 362 & AB 457 – RPTT on sale of controlling interest & Commerce tax on aggregate of a “combined taxpayer” of real estate rentals – were combined and turned into an interim study
 - AB 238 (Sony/Warner Bros/Howard Hughes - Summerlin Campus) Film & Motion Picture Tax Credits
 - SB 220 (Birtcher Development/Gardner Associates- UNLV Henderson campus) – Film & Motion Picture Tax Credits
 - SB 412 – repeal of Excise Tax on bank branch offices
 - Various bills related to tax exemptions, abatements, and credits.

2025 LEGISLATIVE RECAP (CONT.)

- May 2025 Economic Forum projected a \$191 million decrease in revenues for the 2025-2027 biennium
- Next meeting scheduled for December 8
- Special Session??
 - Rumor of November dates
 - Governor's Crime Bill, Affordable Housing Bill, and Economic Development Bill
 - Medicare deficit – early projection was \$20 million, expected to be higher
 - Film Credit bills - only if there are the votes
