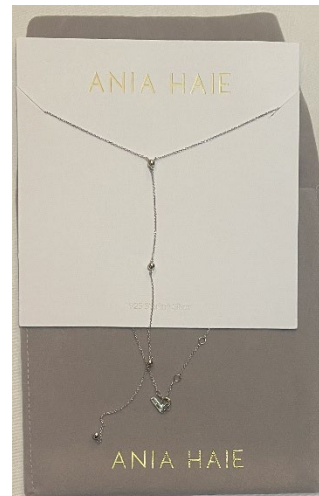

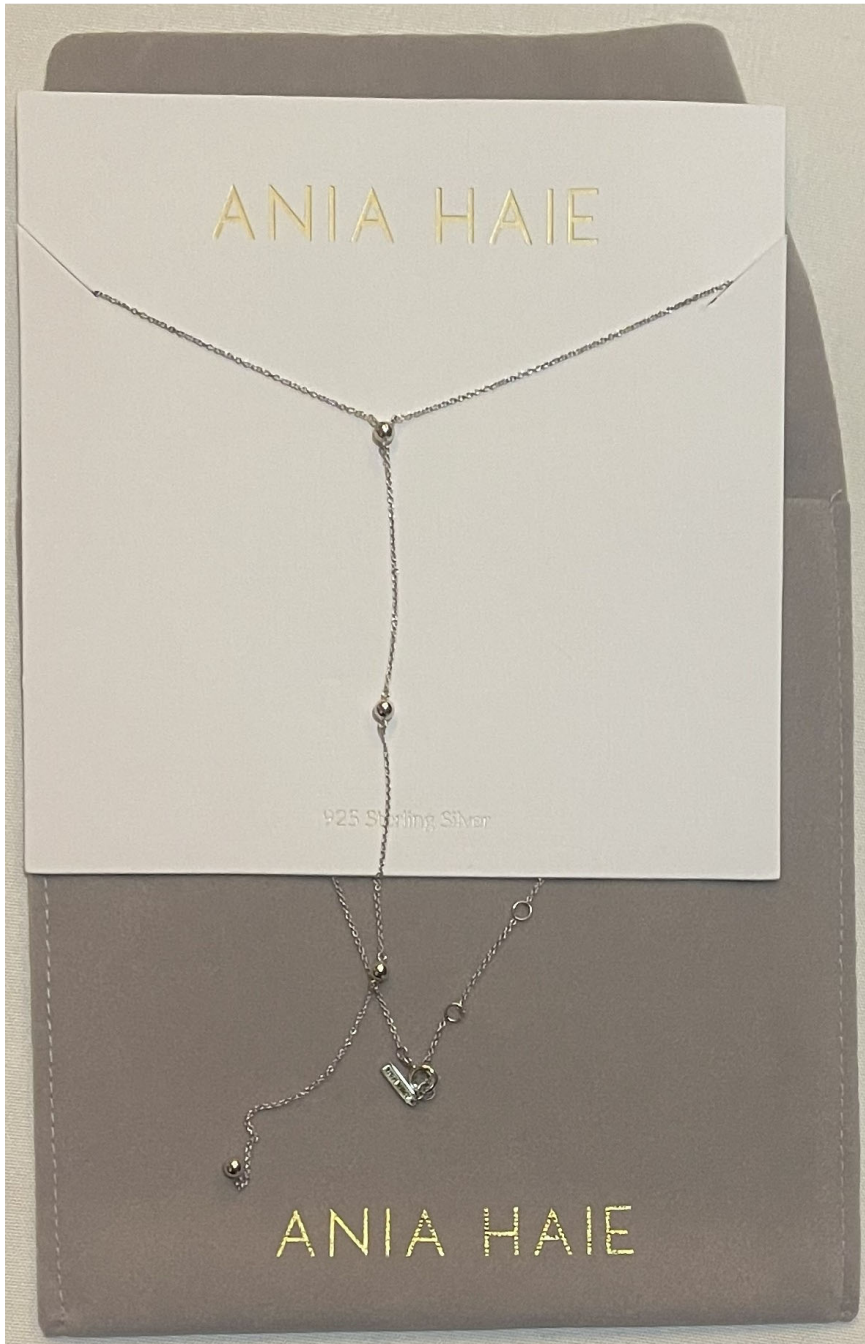

# What Is Economics Really?

# The U.S. Economy in Three Sentences

---

## 1. Debt is up.

Federal debt projected to surpass 100% of GDP. Consumer debt delinquencies rising across credit cards, auto loans, and student loans.

## 2. Savings are down.

Personal savings rate has lagged well behind pre-2020 levels. Household debt obligations are back to pre-pandemic norms — without the cushion.

## 3. Wages still aren't up enough, but they're getting closer.

Cumulative inflation from Jan 2021: +23%. Average weekly earnings: +22%. The gap is real and your customers feel it.

# Las Vegas in Three Sentences

---

## 1. The market is cooling.

Nevada job growth went from 1st in the nation post-2020 to near the bottom for most of 2025. Visitor volume down 6-7% YoY. Real gaming win is flat and real retail sales are declining.

## 2. The talent pool is tight.

Unemployment at 5.2% — above the U.S. average — but growth is in education/health and hospitality, not professional & business services.

## 3. The cost of being here is going up.

Wages up ~50% since 2014 but real wages only up <10%. Housing Prices up ~39%+ (weighted avg) since 2020.
