As a Rotarian, I will

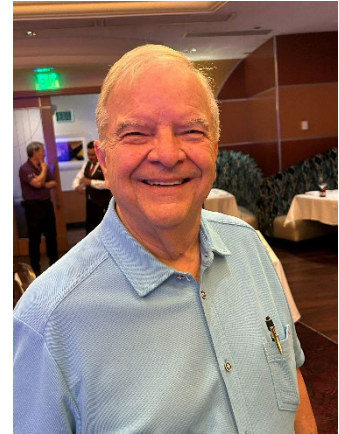
1. Act with integrity and high ethical standards in my personal and professional life

PROGRAM

In honor of the club having been chartered in 1965, today's program was "Where were you and what were you doing in 1965". **Past Pres. Rebecca** called on the following people:

Fred Fukumoto said he had just started his first job as a junior accountant with American's Photocopy Equipment Co. in Evanston, Illinois. Born in the Manzanar Internment Camp in California during WWII, his family subsequently moved to Chicago where he was raised. His move to Las Vegas began in 1982 when he was living in La Mesa, Ca. He started a business here and then moved his family here in 1986. He joined Rotary in February 1987.

Ken Cox said he was living here in Las Vegas and going to school. He said his family moved here in 1962 when he was in the third grade at West Charleston Elementary School (now Wasden Elementary). He subsequently went to Hyde Park Middle school and Clark High School. His father started a plumbing business which he later joined. He joined Rotary in January of 1995.

Ron Reynolds said he was a freshman at BYU majoring in a five-year electrical engineering program. After the fourth year he decided he would rather major in zoology so he switched majors to become a marine biologist. However, after graduating he taught English for a while until his wife told he had better do something to earn more money because she wanted a big family. So, he went to law school and the rest is history...9 children and 44 grandchildren. He moved to Las Vegas in 1976 and joined Rotary in January of 1978.

Jack Woodcock said he was stationed at an undisclosed military base in Holland. It was a Nato Base called Camp New Amsterdam near Utrecht and wasn't supposed to exist. Only 12 personnel permanently assigned there plus the occasional pilots passing through. Apparently, it wasn't all drudgery as he commented that he was in his early 20's and single (although he didn't elaborate on that comment.) He spent two years there after having spent time in Germany as manager of the Armed Forces Radio Station. In 1966 he was sent to Austin, Texas to train as a forward air controller after which he was sent to Vietnam in 1967. He joined Rotary in March 1976.

Tom Novotny said that he was living in Nebraska as one of 4 boys in the family. The town was small and his dad was mayor. He was involved in sports and was a baseball catcher. Following the death of one of his brother's, he said he became serious about life. He joined Rotary in 1982 in St. Louis where he was a VP with a cable TV company. He eventually joined his dad's printing business in Las Vegas in 1993 which he operated until it closed in 2016 and he retired.

Michael Krokower said he was living in Los Angeles and made a big mistake when he married his first wife. She eventually left and he became a single father and raised his two sons. He was working for an electronics company at La Brea and Melrose. After some time passed, he married again and enjoyed a happy 25-year marriage. He lived in the Monterey area until 2021 when he moved to Las Vegas. He joined Rotary in 1989 in Pacific Grove, CA.

Tom Martin said that he was living here in Las Vegas, married with two daughters, and worked for a steel company in North Las Vegas owned by the town's mayor. He joined Rotary in 1982.

Keith Thomas said that he had just completed his first year of college at Ricks College in Idaho where he had followed his girlfriend. He said it took the rest of his college career to get his GPA back up over 3.25. Later that year, he helped his family move to St. George after which he left for a two-year mission in Guatemala and El Salvador. He eventually moved to Las Vegas in 1988 and joined Rotary in 1989.

Bruce Pope said that he married his first wife in 1965. He was working in the crop science department at Michigan state in E. Lansing, MI. He and his "first" wife have been married 61 years. He joined Rotary in May 1988.

Greg Mottau said that he was in his sophomore year at Gonzaga University in Spokane, Washington. His father had told him he could stay home in Portland and go to college and live at home but that he wouldn't help him financially. However, he told **Greg** that if he would move out and go to Gonzaga, he would help with tuition and fees, etc. He also

said his dad told him that he needed to understand loneliness. When he graduated, he also graduated from the ROTC program and began active duty with an emphasis on storage of nuclear weapons. The Army said they were going to send him to the Presidio in San Francisco to learn a language so he thought he would be going to Germany. However, when he arrived, he found that there were 3 Vietnamese ladies there teaching their language. He thought that wasn't a good sign, and indeed he ended up in Vietnam where he was assigned to the Vietnamese Army where he spent an entire year traveling around the country training. He joined Rotary in November 1983.

Cynthia Hamada said that she was 13 and living in San Francisco and was a skilled Kabuki dancer. She was also an amateur singer who performed on a Japanese radio station out of LA because there was no Japanese TV. She was a child star and even provided us with a short sample of her singing...which was great! She joined Rotary in South San Francisco and is an honorary member of Southwest Rotary.
