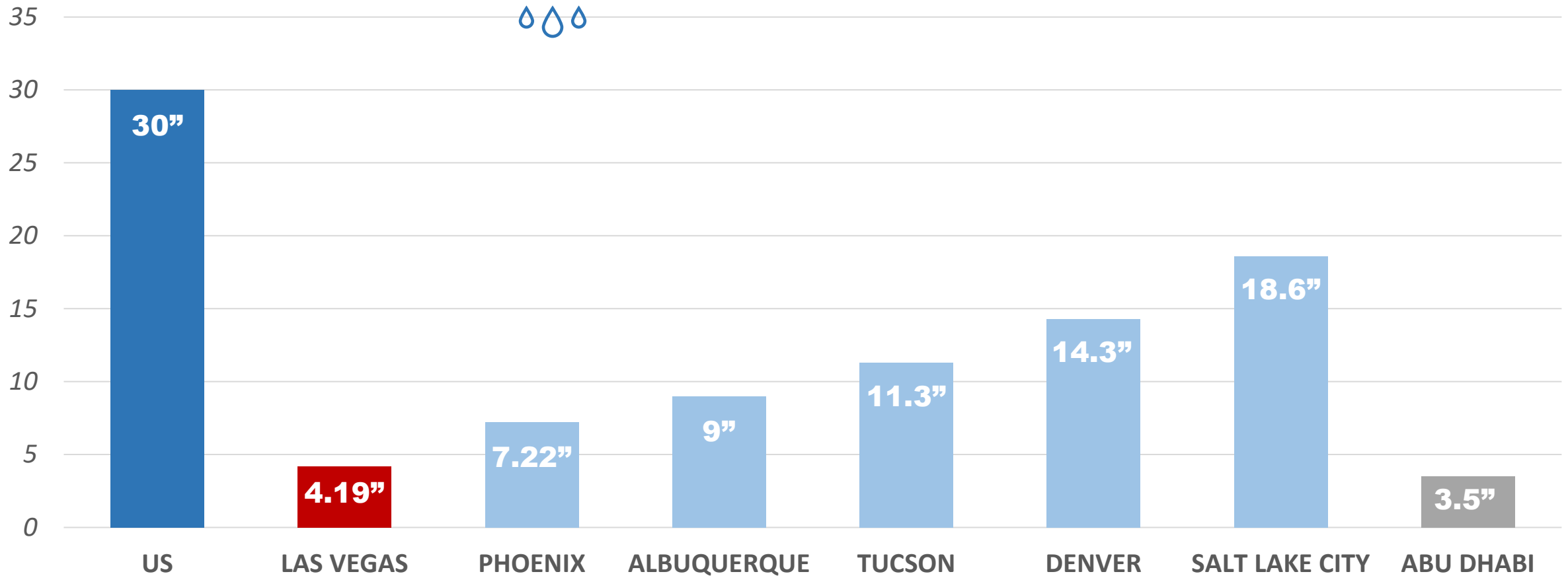

ANNUAL PRECIPITATION IN INCHES

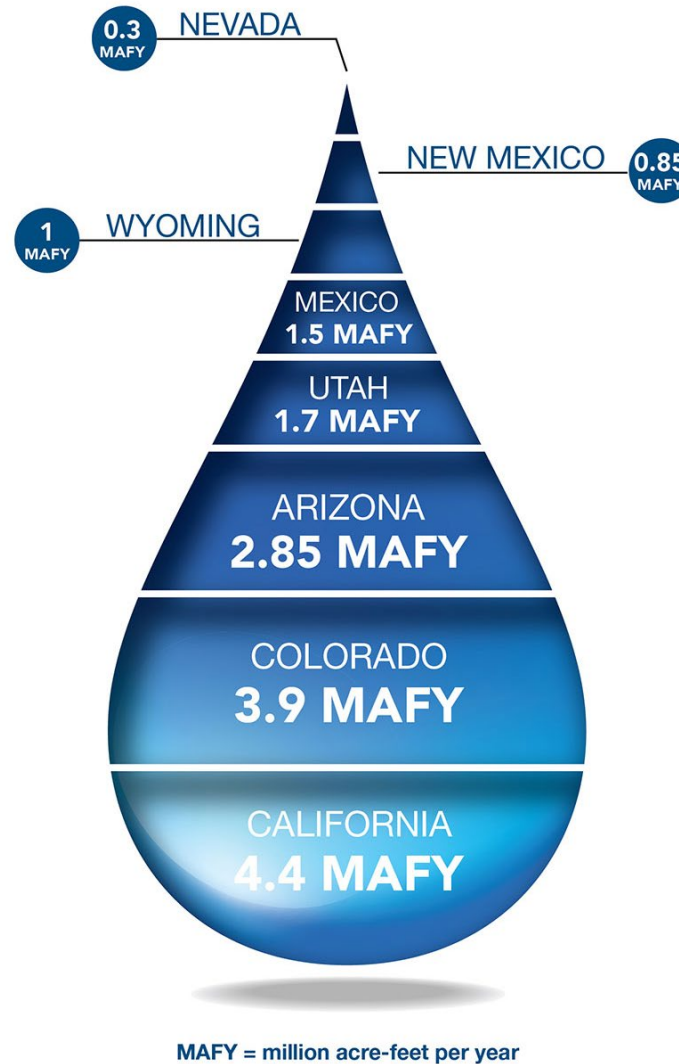


The Colorado River is shared among seven Basin States and the country of Mexico.

Nevada receives the smallest share of Colorado River water.



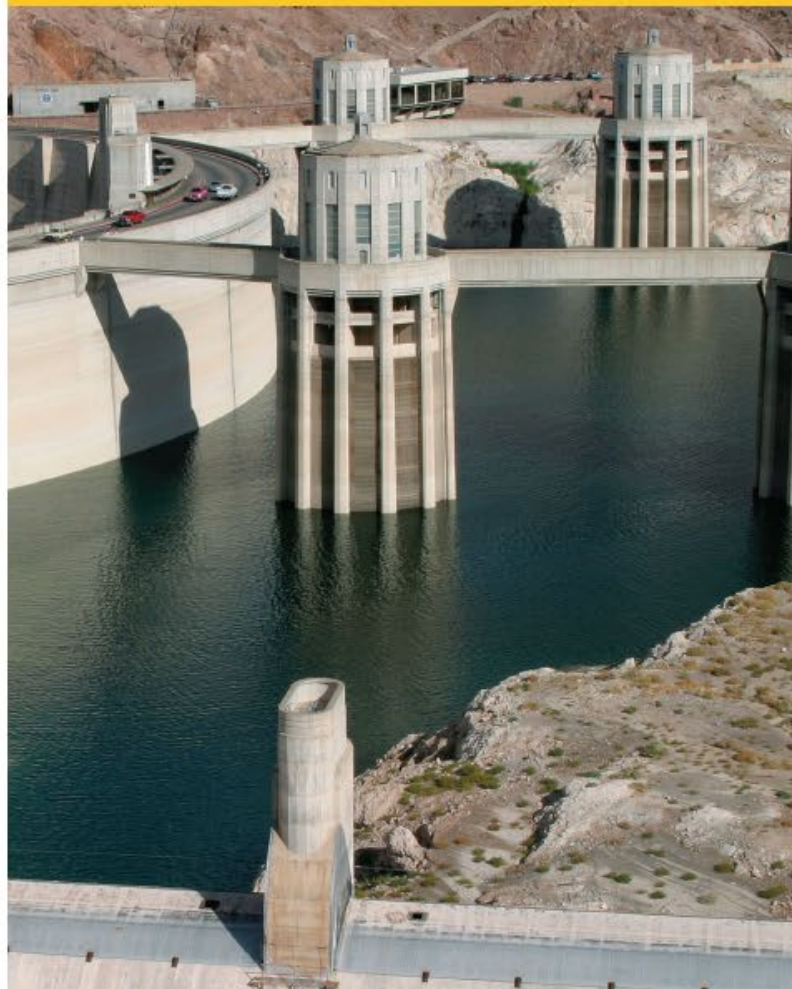

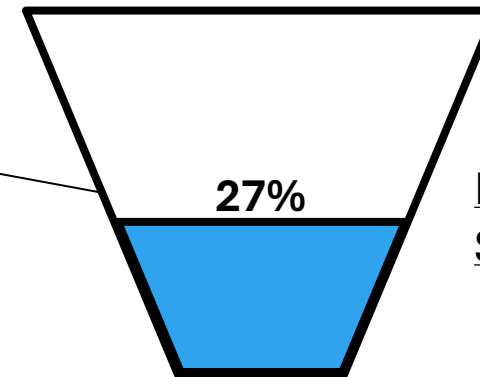

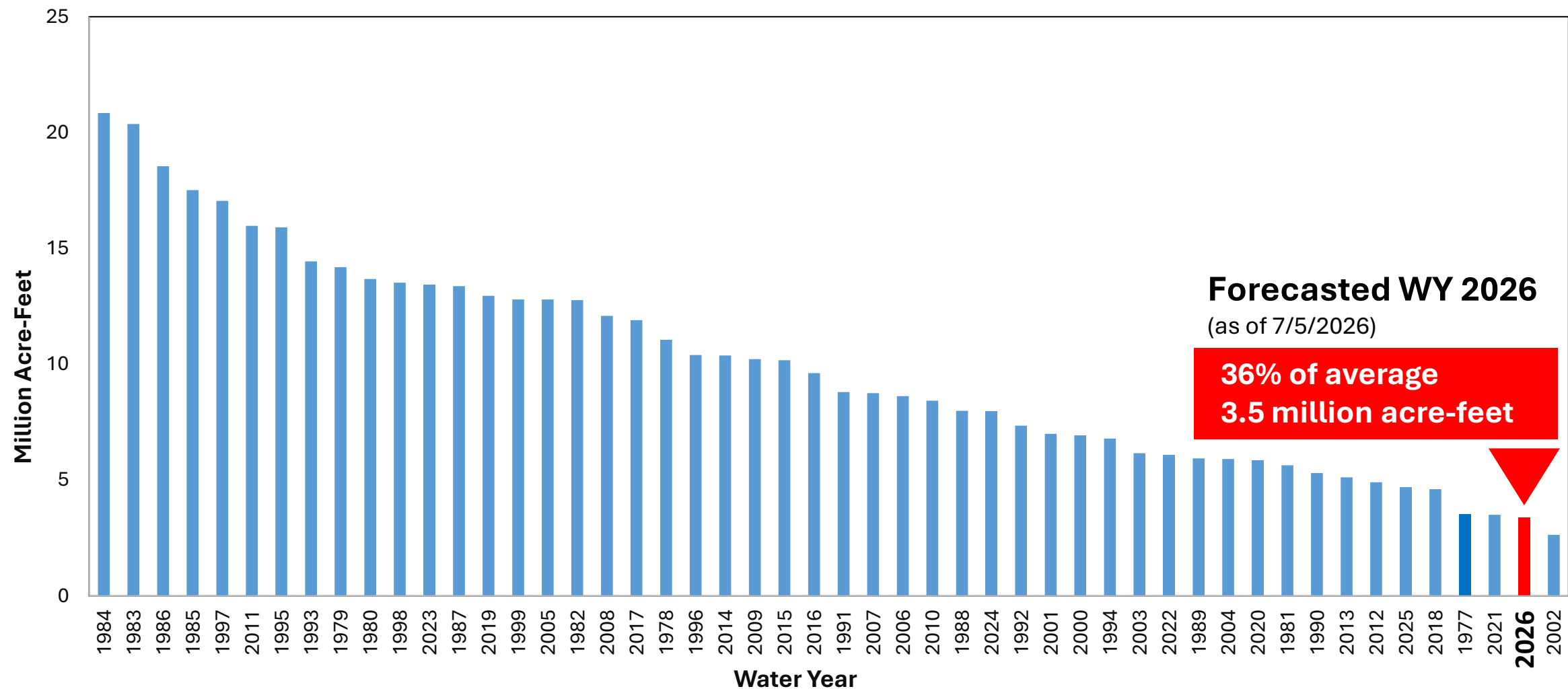

Ranking Unregulated Inflow to Lake Powell

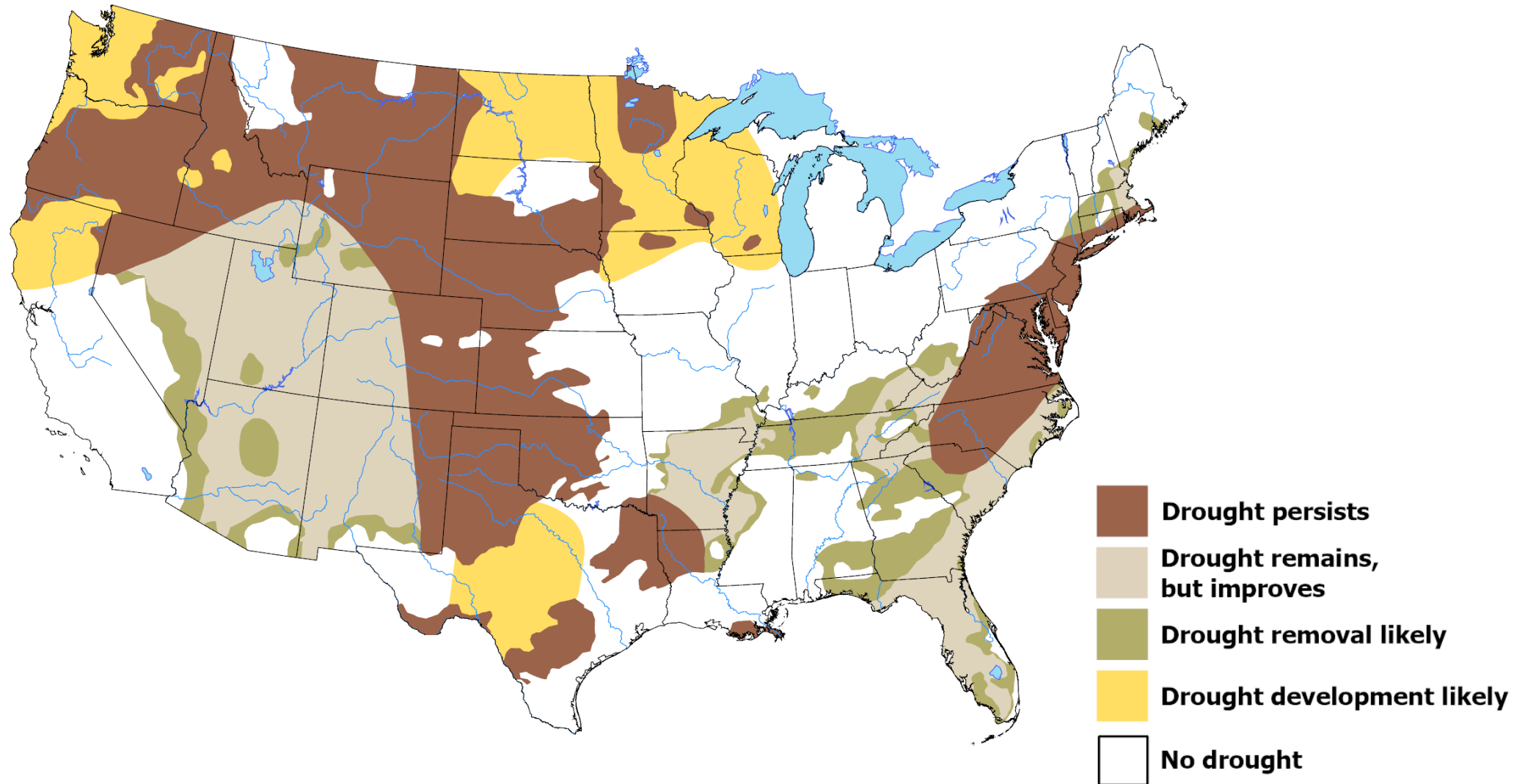

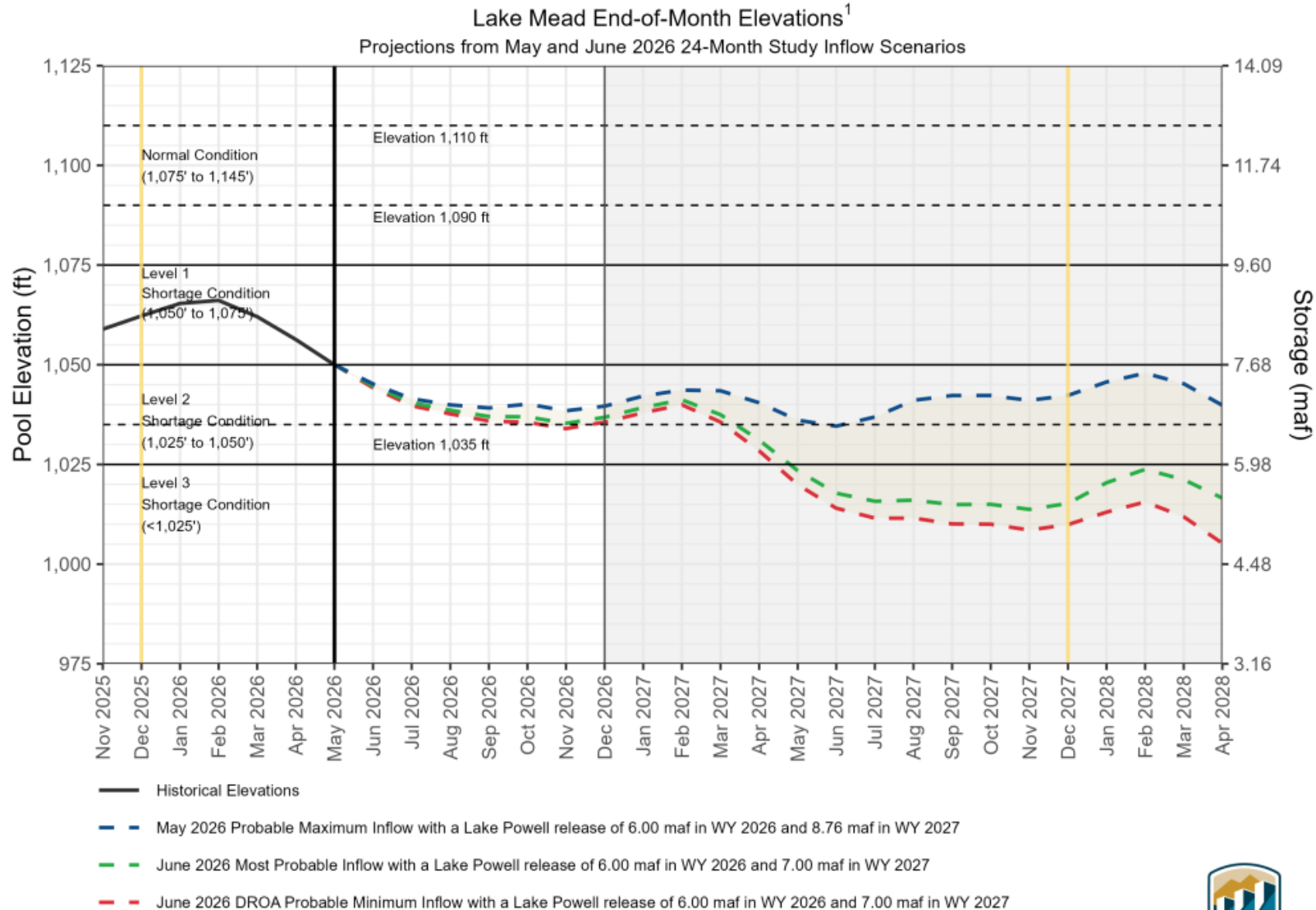

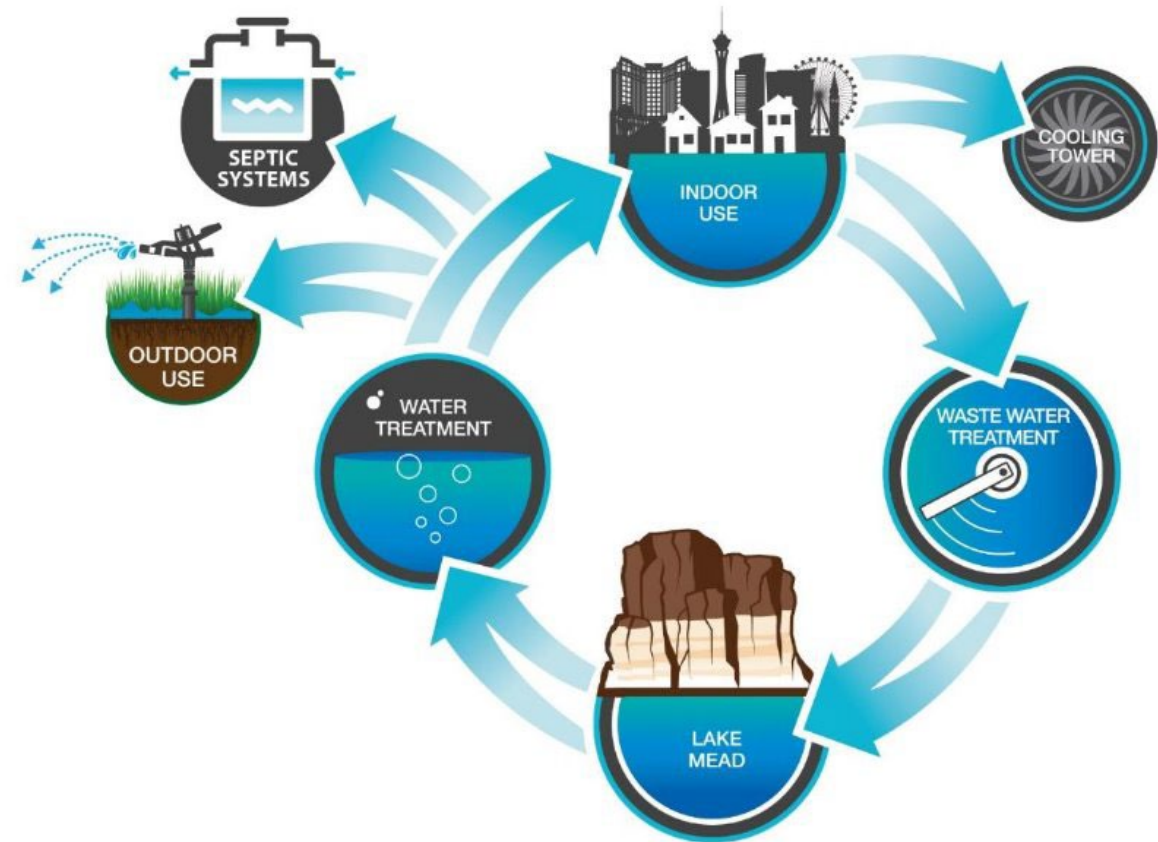

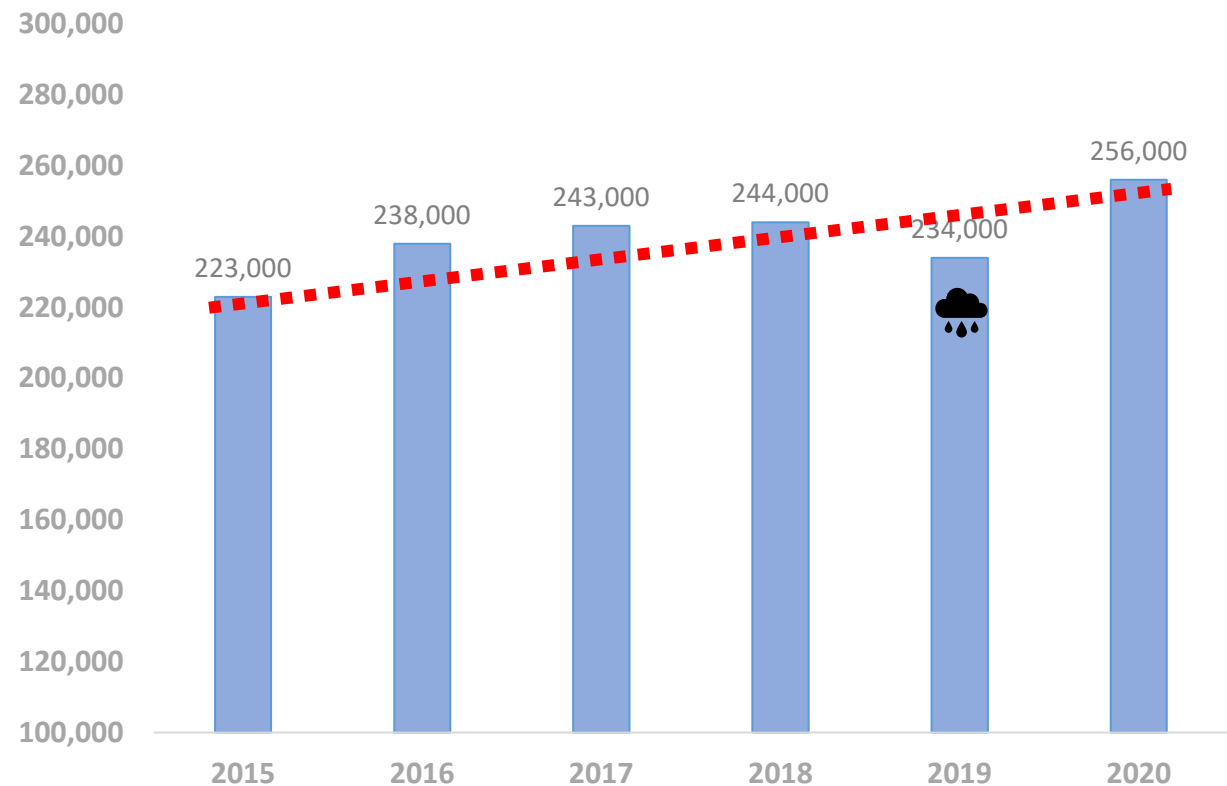

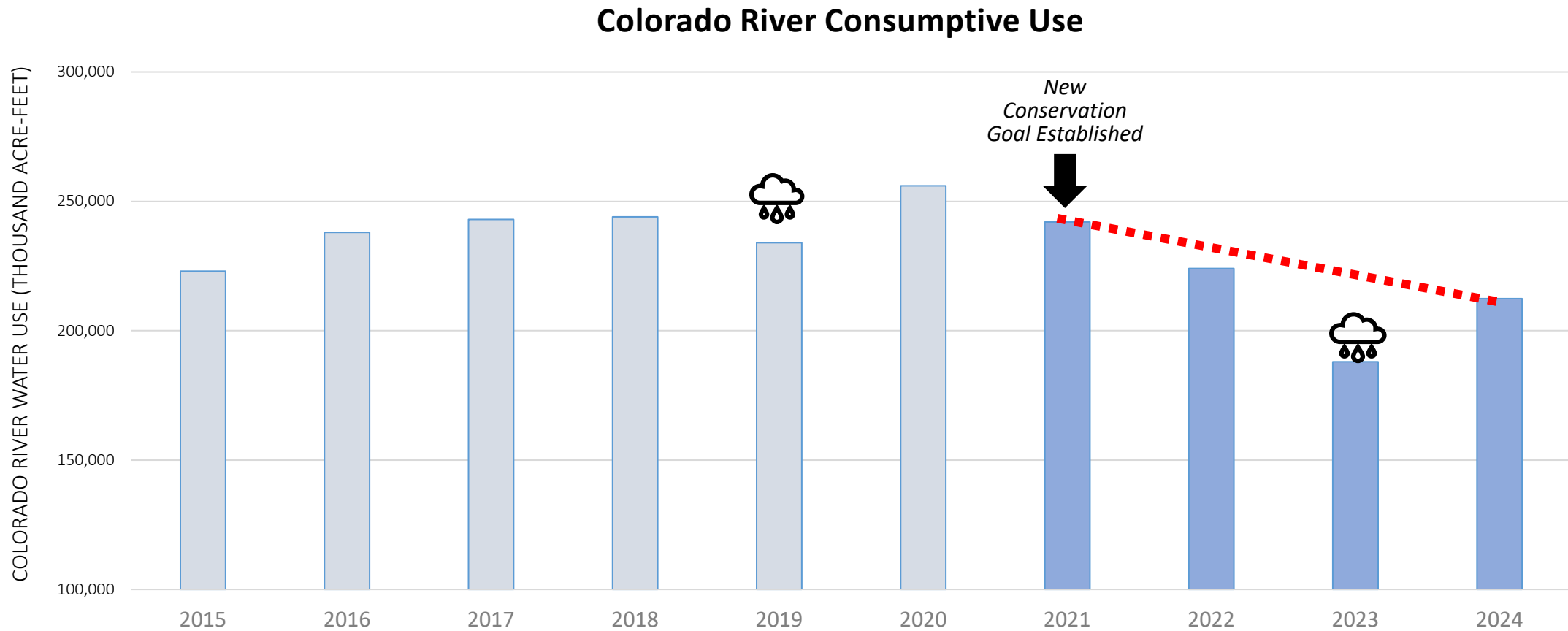

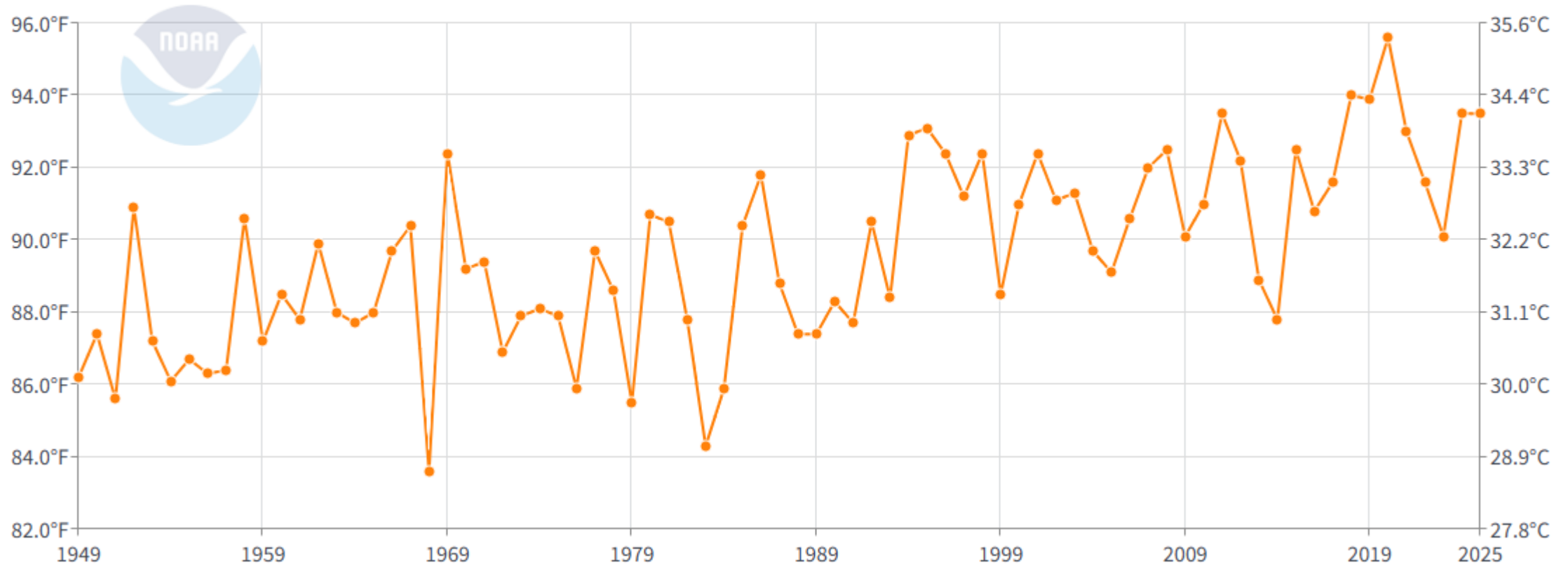
