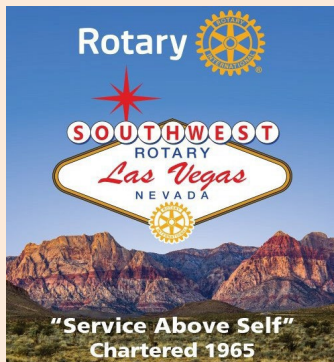

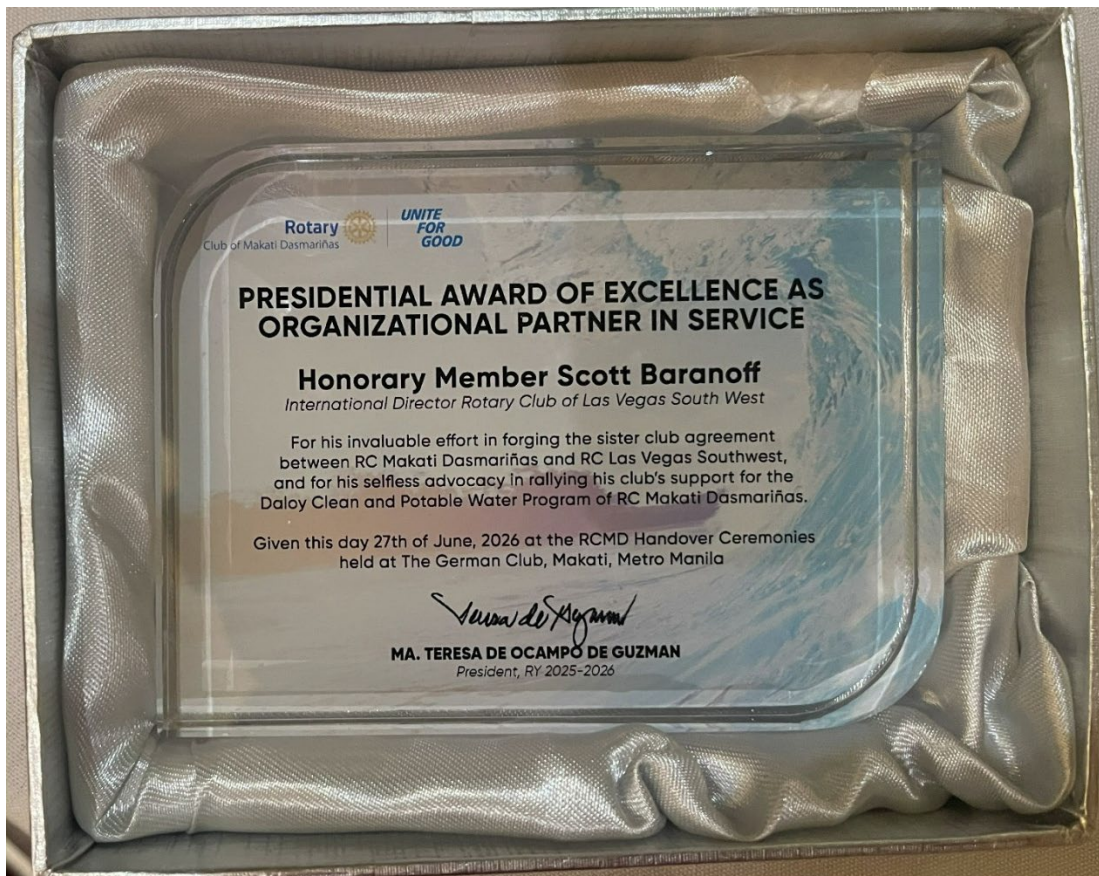

GIFTS FOR THE PRESIDENT (Pres. Jeanne’s recommended gift is coffee mugs.)

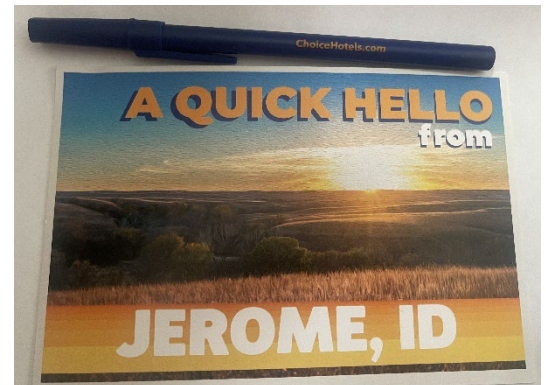

PROGRAM

Our program speakers today were introduced by **PDG Tom Novotny**. Our speakers were **Anthony Vignieri-Greener**, the head coach of the UNLV Hockey team and by **Colin Robin**, an assistant coach. **Tom** has known **Coach Greener** for many years going back to when **Tom's** kids were playing hockey thirty years ago.



Originally from Kenosha, Wisconsin, **Anthony** had a long hockey career as a forward before stepping into his coaching skates. He originally joined the Rebels in 2006, a year after the program started as an ACHA Men's Division II member. He played for five seasons, playing in 114 games, tallying 96 goals, dishing out 169 assists, for a career total of 265 points. His memorable play on the ice can be recognized as his #96 jersey can be seen hanging inside the Hylo Park Arena, keeping his legacy alive. He was named to the ACHA Men's Division II First Team All-Athletic once and ACHA Men's Division II Second Team All-Athletic once. In his last three seasons of play with the Rebels, he helped the team reach the regional tournament, a milestone for the young program at the time. During that time, he was also a part of the Rebels two-season undefeated streak at home, totaling 36 consecutive wins. He graduated from the team in 2011, venturing off to other coaching jobs in the Las Vegas Valley. He began his coaching career for the Las Vegas Jr Wranglers, as well as other Las Vegas-based youth programs, including Pee Wee AA, Bantam AA, U16AA, and U18AA. In 2015, **Anthony** returned to his roots as he took on the role of head coach for the Rebels. It took only two years at the helm before the Rebels made the jump to ACHA Men's Division I hockey. Since joining ACHA Men's Division I, the Rebels have not missed a playoff run qualifying seven times. He enjoys family time when he is not on the ice. He has his wife, Ashley, his three daughters.

Colin Robin is an assistant coach for the University of Nevada-Las Vegas (UNLV) Skatin' Rebels hockey team. He played college hockey growing up and transitioned into coaching and athletic performance, holding a master's degree and working with off-ice training. He has been a key part of the coaching staff helping guide the Rebels to high-profile seasons, including the program's historic ACHA National Championship run.





They are also assisted by assistant coach, **Nick Robone**. Nick is a Las Vegas native who is in his 12th year of coaching with UNLV's team. Nick was attending the 10/1 concert when he suffered a gunshot wound to the chest. He was initially tended to by his paramedic brother, **Anthony**, and his friends. He is married and has two sons.

Their presentation was well received and was met with many questions from our members. A copy of their slide deck is attached below.
